**Chapter 219.**

An act authorizing the Kennebec Telegraph Company to lease or sell their line.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

The Kennebec Telegraph Company is hereby authorized and empowered to lease to the American Telegraph Company, on such terms and for such period as the corporators may deem expedient, their line of telegraph from Augusta to Bath in this state, with the posts, wires, batteries and other fixtures and appurtenances thereof, or at any time within five years to sell the same to any legally authorized company or companies. And this act shall take effect on its approval by the governor.

Authorized to lease.

May sell within five years.

Approved February 14, 1863.

**Chapter 220.**

An act to incorporate the Master, Wardens and Members of the Mt. Kineo Lodge.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. Simeon Mudgett, Sumner A. Patten, Peabody H. Rice, Morrill Prescott, Walter Jewett and David R. Straw, junior, their associates and successors, are hereby constituted a body corporate by the name of the Master, Wardens and Members of Mount Kineo Lodge, to be established and have their place of business at Abbot, in the county of Piscataquis, with power to sue and be sued, to make any by-laws not inconsistent with the laws of this state, to take and hold for charitable and benevolent uses any real estate to the value of five thousand dollars and personal estate to the value of ten thousand dollars, with the right to convey the same, and generally to exercise all the rights and be subject to all the liabilities of corporations in this state created for charitable and benevolent purposes.

Corporators.

Corporate name.

By-laws.

May hold real and personal estate.

Rights, privileges, &c.

SECT. 2. The first meeting of said corporation shall be called by posting up written notices of the same in two public places in the village of Abbot, and a like notice in the village of Monson, seven days previous thereto, defining in said notices the time, place and purposes of said meeting ; and Simeon Mudgett is authorized to give said notice.

First meeting, how called.

SECT. 3. This act shall be in force upon its approval by the governor.
