CHAP. 277. apart for such city, town or plantation, so long as such tax remains unpaid.

SECT. 6. This act shall take effect when approved by the governor.

Chapter 277.

An act to incorporate the Warren Manufacturing Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Corporators.

SECT. 1. Amos H. Hodgman, Samuel L. Hodgman, Albert Johnson, Andrew Fuller of Warren, and Francis Cobb of Rockland, in the county of Knox, and Isaac Reed and B. B. Haskell of Waldoborough, in the county of Lincoln, with their associates, successors and assigns, are hereby constituted a body politic and corporate by the name of the Warren Manufacturing Company, for the purpose of manufacturing cotton and woolen goods, and flour and meal; also iron, steel and wood into various machinery and merchandise, in the town of Warren; and may have and hold real and personal estate to an amount not to exceed at any one time seventy-five thousand dollars in value, with power to give, grant, sell and dispose of the same; and shall have all the powers and privileges and be subject to all the duties, liabilities and requirements of the several acts of this state defining the general powers and duties incident to manufacturing companies.

Corporate name.

May hold real and personal estate.

Powers, privileges, &c.

Shares.

SECT. 2. The amount of capital stock in this corporation shall be divided into shares of one hundred dollars each.

First meeting, how called.

SECT. 3. The first meeting may be called by any three of the above named corporators, by publishing a notice of the time, place and purposes thereof, three weeks successively, in any newspaper published in Knox county.

SECT. 4. This act shall take effect on approval by the governor.

An act to incorporate the Gorges Monument Association.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Libby and William Moulton, their associates and successors, be and they are hereby incorporated and made a body politic and corporate by the name of the Gorges Monument Association, with all the powers and subject to all the duties of aggregate corporations, and for the purposes hereinafter mentioned.

Corporate name.

SECT. 2. Said corporation shall have power to take and hold by gift, grant or devise, such real and personal estate as may be necessary or convenient to promote the object of this incorporation, the construction of a monument in this state to perpetuate the memory of the events of the early history of New England, and in honor of the memory of Sir Ferdinand Gorges, the first proprietor of the province of Maine, and the father of English colonization in America.

May hold real and personal estate.

Object and purposes.

SECT. 3. Said corporation may establish by-laws, appoint trustees, and take such measures as will secure the objects of this grant, not inconsistent with the laws of this state.

By-laws.

SECT. 4. Any two of the three persons first named in the first section of this act may call the first meeting of said corporation, by giving fourteen days public notice thereof in some newspaper printed in Portland in this state.

First meeting, how called.

SECT. 5. This act shall take effect from and after its approval by the governor.

Approved March 24, 1868.
