## PUBLIC LAWS

# STATE OF MAINE.

1864.

An act to change the time of holding the August and November terms of the supreme judicial court in Oxford county.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

The supreme judicial court shall be holden on the third Tuesday of September annually, at Paris, within and for the county of Oxford, instead of the second Tuesday of August; the same court shall be holden on the second Tuesday of December annually, at Paris, within and for the county of Oxford, instead of the second Tuesday of November as is now provided by law.

Sect. 2. All matters pending in or returnable to said court and which would, but for the provisions of this act, have day at the term of said court to be held on the second Tuesday of August of the present year, as by law provided, shall be returnable to, and have day at the term of said court to be held on the third Tuesday of September of the current year. All matters pending in or returnable to said court and which would, but for the provisions of this act, have day at the term of said court to be held on the second Tuesday of November of the present year, as by law provided, shall be returnable to and have day at the term of said court to be held on the second Tuesday of December of the current year.

#### Chapter 256.

An act relating to the duties and compensation of the secretary of state, and the clerks employed by him.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Sect. 1. The secretary of state shall be paid an annual salary of fifteen hundred dollars, which shall be a full compensation for all services rendered by him by virtue of his office; and said secretary shall keep an accurate account of all fees received by him in his office, and he shall, in the month of December in each year, make return thereof, under oath, to the governor and council, and pay over the amount of such fees to the state treasurer.

After the first day of April next, said secretary may employ one chief clerk, who may act as deputy secretary, and whose compensation shall be eleven hundred dollars per annum; also one other clerk, who shall receive ten hundred dollars a year. Temporary clerks may be employed in the office of secretary of Temporary state from time to time during each year, as the exigencies of the
