Chapter 374.

Снар. 374.

An act to incorporate the Veazie Manufacturing Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

That John W. Veazie, Orlando W. Gilman and Charles Corporators. Darrow, their associates, successors and assigns, are hereby incorporated into a company by the name of the Veazie Manufacturing Corporate Company, with all the powers, privileges and immunities, and subject to all the duties and liabilities provided by the laws of the privileges, &c. state concerning manufacturing corporations; and said corporation May hold real is authorized to purchase and hold, sell, lease and improve real and personal estate to the amount of five hundred thousand dollars, in the towns of Veazie and Eddington, and divide the same into shares Shares. as they may deem convenient; and said company are authorized to carry on the manufacture of cotton, wool, iron, wood and other articles, not contrary to the laws of the state, and for that purpose may purchase or erect on their own lands at Veazie and Eddington, such buildings, mills and machinery, and dam across the river, as may be useful or necessary; provided, that such dam shall not Proviso. be so constructed as to prevent the passage of rafts through or by the same, but shall be furnished with all proper and convenient locks or sluices for that purpose, to be kept in repair and open and convenient for passage, at the expense of the corporation and without toll; the said works, improvements and erections to be so constructed as not to injure or flow any property other than their own, beyond their present rights. The said works are to be subject to all statutes of this state relating to fishways.

Sect. 2. The first meeting of said corporation may be called by either of the persons named in this act, serving a written notice on how called. each of the others, stating the time, place and object of such meeting at least five days before the time of said meeting.

This act shall take effect from and after its approval by the governor.
