**Chapter 297.**

Resolve in favor of Eliza C. Prouty, of township number two, range three, in the county of Aroostook.

*Resolved,* That there be paid out of the state treasury to Eliza C. Prouty, of township number two, range three, the sum of one hundred and twenty-seven dollars, and that the governor be authorized to draw his warrant on the treasury for the same.

Eliza C. Prouty, in favor of.

Approved February 29, 1864.

**Chapter 298.**

Resolve to appropriate money for the repairs of the Rocky Rips bridge in township number one, Penobscot county.

*Resolved,* That there be appropriated and paid out of the state treasury, to be expended under the direction of the land agent, the sum of fifty dollars, for repairs on the bridge over the Passadumkeag river, in township number one, north division, in the county of Penobscot, on the road from Lowell to near the mouth of Olaman stream in Greenbush.

Approved March 2, 1864.

**Chapter 299.**

Resolves establishing the valuation of the towns of Columbia and Columbia Falls.

*Resolved,* That the number of polls set to the valuation of the town of Columbia be one hundred and sixty-one, and the value of estates one hundred eleven thousand one hundred sixty-three dollars.

Columbia, valuation of, established.

*Resolved,* That the number of polls set to the town of Columbia Falls be one hundred and thirty-five, and the value of estates one hundred thirty-eight thousand and eighty-one dollars.

Columbia Falls, valuation of, established.

**Chapter 300.**

Resolve relating to the president and vice president of the United States.

*Resolved,* That for their eminent services to their country in the years of its gravest peril, president Abraham Lincoln and vice

**CHAP. 301.** president Hannibal Hamlin are deserving the confidence and regard of the American people, and that in the opinion of this legislature the loyal citizens of Maine desire their reelection to the offices which they now so ably and faithfully fill.

### Chapter 301.

Resolve laying a tax on the several counties in this state.

County taxes,  
providing for.

*Resolved,* That the sums annexed to the counties in the following schedule, are hereby granted as a tax on each county respectively, to be appropriated, assessed, collected and applied for the purpose of paying the debts and necessary expenses of the same, and other purposes ordered by law, to wit :

Androscoggin, eighteen thousand dollars ; Aroostook, six thousand one hundred dollars ; Cumberland, forty-three thousand eight hundred sixty dollars ; Franklin, six thousand dollars ; Hancock, eight thousand five hundred dollars ; Kennebec, nineteen thousand nine hundred seventy dollars ; Knox, nine thousand dollars ; Lincoln, eight thousand dollars ; Oxford, nine thousand dollars ; Penobscot, nineteen thousand dollars ; Piscataquis, three thousand dollars ; Sagadahoc, eight thousand five hundred dollars ; Somerset, seven thousand five hundred dollars ; Waldo, nine thousand five hundred dollars ; Washington, ten thousand dollars ; York, ten thousand dollars.

### Chapter 302.

Resolve in aid of the widow of Himenas Philbrick.

Himenas Phil-

*Resolved,* That the land agent be authorized and directed to convey to the widow of Himenas Philbrick, lot number fifty-three, in township fourteen, range three, in the county of Aroostook, waiving further settling duties and balance due for road labor.
