#### Chapter 299.

Снар. 299.

An act in addition to an act approved March nineteen, eighteen hundred and sixty-two, entitled "an act to regulate agencies for, and to prevent imposition in the sale of intoxicating liquors.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

The commissioner provided for in the act approved March nine- Commissioner teen, eighteen hundred and sixty-two, entitled "an act to regulate may sell to agencies for and to prevent imposition in the sale of intoxicating states. liquors." may sell to duly authorized agents of cities and towns in other states under the same duties and penalties as are now provided for the regulation of sales to agents in this state.

Approved February 20, 1865.

#### Chapter 300.

An act to amend chapter one hundred and one of the revised statutes, entitled "writ for replevying a person," and chapter one hundred and thirty-five of the revised statutes. entitled "sentence and its execution in criminal cases, and the liberation of poor convicts."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Sect. 1. Section third of chapter one hundred and one of the revised statutes, is hereby amended by inserting in the third line after the word "sheriff," the words, or his deputy.

R. S., chap. 101, sec. 3, amended.

Section ten of chapter one hundred and thirty-five of the revised statutes, is hereby amended by inserting between the word "to" and the word "and" in the seventh line, the following words: -which oath may be administered by the sheriff, jailer or any justice of the peace or trial justice.

#### Chapter 301.

An act to amend chapter nine of the public laws of eighteen hundred and sixty-one, concerning the exemption of sewing machines from attachment and execution.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Sect. 1. Chapter nine of the public laws of eighteen hundred and sixty-one entitled "an act to exempt certain property from attachment and execution," is hereby amended by striking out the
