PRIVATE AND SPECIAL LAWS

OF THE

STATE OF MAINE.

1865.

CHAP. 431. upon the whole line of said road, subject only to existing mortgages.

Shall transport freight and passengers of York and Cumberland road.

SECT. 2. Said corporation shall, on request, transport the freight and passengers coming from, or going to the York and Cumberland Railroad, or any other connecting railroad, at all reasonable times, and for a toll not exceeding its ordinary rates.

SECT. 3. This act shall take effect from its approval by the governor.

Chapter 431.

An act additional to "an act to incorporate the East Branch Mattawamkeag Dam Company."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Authorized to improve navigation of stream above and below dam.

Expenses to be added, &c.

SECT. 1. The East Branch Mattawamkeag Dam Company is hereby authorized to improve the navigation of the stream, above and below their dam, for driving logs, by deepening the channel, removing obstructions and doing such other acts as may be necessary for that purpose; the expenses of which, including those already incurred, may be added to those for building the dam, to be reimbursed in the manner provided by their original charter.

SECT. 2. This act shall take effect from and after its approval by the governor.

Chapter 432.

An act to incorporate Crescent Lodge.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Incorporators.

Corporate name.

May sue and be sued, have a seal and make by-laws.

SECT. 1. Bailes Atkinson, Thomas J. Sherman, John C. Walker, W. E. Leighton, L. T. Reynolds, Isaac Mincher second, John Mincher, A. R. Stoddard and Daniel W. Wilder, with their associates and successors, are hereby incorporated into a body politic by the name of Crescent Lodge, established at Pembroke, in the county of Washington, with power to sue and be sued; to have a common seal and change the same; to make any by-laws for the management of their affairs not repugnant to the laws of this state; to take and hold for charitable and benevolent uses, any real estate

to the value of three thousand dollars, and any personal estate to the value of three thousand dollars; and to give and grant, or bargain and sell the same; and with all the privileges usually granted to other societies instituted for the purposes of charity and beneficence.

SECT. 2. Bailes Atkinson is hereby empowered and authorized to fix the time and place of holding the first meeting of said corporation, and that it be notified in such manner as he may direct.

SECT. 3. This act shall take effect when approved by the governor.

Chapter 433.

An act to change the limits of Ticonic Village Corporation

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. The territory in the town of Waterville, county of Kennebec, lying west of Emerson stream and north of the south line of lot numbered eleven, on fifteen mile lot, B one, on Doctor John McKechnie's plan, which is included within the limits of Ticonic Village corporation, with the inhabitants thereon, be set off from said corporation.

Certain territory and persons set off from Ticonic village corporation.

SECT. 2. This act shall take effect and be in force when approved by the governor.

Chapter 434.

An act to amend chapter four hundred and seventy of the special laws of eighteen hundred and sixty, relating to the destruction of fish in Chandler's river.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. The third section of chapter four hundred and seventy of the special laws approved March twentieth, eighteen hundred and sixty, entitled "an act to prevent the destruction of fish in Chandler's river," is hereby repealed.

Sec. 3 of chap. 470 of special laws of 1860; repealed.

SECT. 2. This act shall take effect when approved by the governor.
