Chapter 74.

Спар. 74.

An act to incorporate the South Berwick Boot, Shoe and Leather Manufacturing Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Sect. 1. J. H. Burleigh, E. M. Jewett, John B. Nealley, Marcus M. Albee, Alonzo Stackpole, Nicholas Hanson, E. R. McIntire, A. J. Nealley, Josiah Paul, Theodore H. Jewett, George W. Keays, Andrew Whitehouse, Lewis Furgerson, their associates, successors and assigns, are hereby made and constituted a body politic and corporate by the name of the South Berwick Boot, Shoe and Leather Manufacturing Company, with all the powers and privileges, and subject to all the duties and liabilities provided by the laws of this state relating to manufacturing corporations.

Corporate name, powers, duties, &c.

Sect. 2. The said corporation is authorized to engage in the manufacture of boots, shoes and leather, in the town of South Ber- purpose. wick, in the county of York, and to sell the products of such manufacture there or elsewhere.

The capital stock of said corporation shall be two hun-Capital stock, dred and fifty thousand dollars, divided into shares of one hundred shares, &c. dollars each, and said corporation is authorized to purchase, hold, improve, lease or sell real and personal estate not to exceed at any one time, in value, the sum of two hundred and fifty thousand dollars.

SECT. 4. Either of the persons herein named as corporators, may First meeting. call the first meeting of the corporation, by giving three days personal notice to the other corporators.

Chapter 75.

An act creating the South Paris Village Corporation.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

The territory embraced within the limits of school district number two in the town of Paris, together with the inhabitants thereon, be, and the same hereby is created a body politic and corporate by the name of the South Paris Village Corporation.

Corporation

Said corporation is hereby invested with power, at Powers and any legal meeting called for the purpose, to raise such sums of purposes. money as may be sufficient for the purchase, repair and preservation of one or more fire engines, engine houses, hose, buckets,
