## CHAP. 92.

Capital and shares.

*Sect. 2. The capital stock of said corporation shall consist of thirty thousand shares of the par value of five dollars for each share.*

SECT. 2. This act shall take effect when approved.

Approved February 15, 1866.

### Chapter 92.

An act to extend the act entitled "an act to authorize the city of Bangor to aid the construction of the European and North American Railway."

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Ch. 406, special laws 1864, extended.

SECT. 1. The act entitled "an act to authorize the city of Bangor to aid the construction of the European and North American Railway," approved March twenty-fifth, eighteen hundred and sixty-four, is hereby extended for the further term of two years, so that the provisions of said act shall continue in full force and apply to the grant of aid from said city, in case the line of said railway is extended to Lincoln within three years from the time of the approval hereof by the governor.

To be accepted by city of Bangor.

SECT. 2. This act shall not take effect until it shall have been duly accepted by the said city of Bangor, by a vote of the legal voters thereof voting in ward meetings, duly and legally called, within eleven months from and after its approval, and by a majority of at least three fourths of the legal voters of said city, present and voting at said meetings as aforesaid. The returns of such ward meetings shall be made to the aldermen of said city, and by them counted and declared, and the clerk of said city shall make record thereof, and if the act shall be accepted as aforesaid, then after such acceptance and record thereof, all the parts of this act shall take effect and be in full force thereafter.

### Chapter 93.

An act to authorize the county commissioners of the county of Kennebec to appropriate money to rebuild or repair a bridge over the Sebasticook river in Clinton Gore.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Rebuilding and repair of Learned Bridge authorized.

SECT. 1. The county commissioners of the county of Kennebec are hereby authorized to appropriate and expend money to rebuild or repair so much of the Learned bridge over the Sebasticook river

from Clinton Gore in the county of Kennebec, to Burnham in the county of Waldo, as is located in said county of Kennebec.

CHAP. 94.

SECT. 2. This act shall take effect on its approval by the governor.

Approved February 16, 1866.

### Chapter 94.

An act to make valid the doings of the town of Machias.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. The acts and doings of the town of Machias at a meeting held in March, eighteen hundred and sixty-five, wherein the town voted to pay one hundred dollars to volunteers who enlisted in the military service of the United States in eighteen hundred and sixty-one, are hereby made valid.

SECT. 2. This act shall take effect on its approval by the governor.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Alonzo F. Picket of Kittery, shall be allowed to take the name of Alonzo Forest Wilson ; Willard Potter of Lee, shall be allowed to take the name of Willard Knight ; Drusilla A. Soudan of Bangor, shall be allowed to take name of Drusilla A. Flanders, and her daughter, Presilla J. Soudan, shall be allowed to take the name of Presilla J. Flanders ; Hannah Frances Lane shall be allowed to take the name Annie Frankie Hodgdon ; Elizabeth P. Savage of Solon, shall be allowed to take the name of Elizabeth P. Wilson ; Myrta Adelaide Rollins of Solon, shall be allowed to take the name of Myrta Adelaide Langley ; Lewellyn A. Rich of Harrison, shall be allowed to take the name of Lewellyn Ambrose Trafton ; Waterborough B. Fisher of Lewiston, shall be allowed to take the name of Waterborough Fisher Collins ; Storer S. Graffam of Westbrook, shall be allowed to take name of Storer S. Knight ; Anne Elizabeth Steinorth of Portland, shall be allowed to take name of Anne Elizabeth White ; Prentiss N. Black of Limington, shall be allowed
