Chapter 140.**CHAP. 140.**

An act amending section three of chapter seventy-eight of the acts and resolves of eighteen hundred sixty-one establishing the police court of the city of Rockland.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. Section three of chapter seventy-eight of the acts and resolves of eighteen hundred sixty-one, is hereby amended by striking out the word "twenty" in the third line and inserting the word *fifty* in its stead, and by striking out the words "such sentence as is provided by law for such offence," in the fourth line, and inserting instead thereof the words, *sentence of imprisonment in the county jail or house of correction not exceeding one year, or fine not exceeding one hundred dollars*, so that the section as amended shall read as follows :—

Amendment.

SECT. 3. Said judge shall have jurisdiction in all cases of simple larceny when the property alleged to have been stolen shall not exceed in value, the sum of fifty dollars, and on conviction award sentence of imprisonment in the county jail or house of correction not exceeding one year, or fine not exceeding one hundred dollars, and shall have exclusive jurisdiction of all offences against the ordinances and by-laws of said city, though the penalty therefor may accrue to said city ; and in the prosecutions on any such ordinances, or by-laws, or any special law of the state relating to said city, such by-law, ordinance, or special law, need not be recited in the complaint or process, nor the allegations therein be more particular than in prosecutions on a public statute.

Jurisdiction and powers of judge.

Form of complaint, &c.

SECT. 2. This act shall take effect when approved by the governor.

Chapter 141.

An act to amend "an act to incorporate Norway Savings Bank."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. The name of E. A. Holmes is hereby stricken out and the name of Ezra F. Beal inserted instead thereof in the first line of the first section ; and the name of said Beal is stricken out wherever it occurs subsequently in said section.

Amendment.

SECT. 2. This act shall take effect when approved.

Approved February 21, 1866.
