Chapter 79.

CHAP. 79.

An act to amend chapter forty-one of the public laws of the year eighteen hundred and sixty-six, relating to salary of county attorney of the county of Knox.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. The act to increase the salary of the county attorney of the county of Knox, is hereby amended by inserting after the words "five hundred dollars," the words *which shall be in full for all official services.*

Salary of co. attorney of Knox co. \$500, to be in full for all official services.

SECT. 2. This act shall take effect when approved by the governor.

Approved February 12, 1867.

Chapter 80.

An act relating to bills of exchange.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

No person within this state shall be charged as an acceptor of a bill of exchange, draft or written order, upon an acceptance hereafter made, unless his acceptance shall be in writing, signed by himself or his lawful agent.

No person to be charged as acceptor, &c.

Chapter 81.

An act to amend chapter ninety-two of the public laws of eighteen hundred fifty-nine, relating to the annual distribution of school blanks.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. Section one of chapter ninety-two of the public laws of eighteen hundred and fifty-nine shall be amended by striking out the words "superintending school committee," and inserting in their stead the word *clerk*, and by adding thereto the words following, *and said clerk shall forthwith deliver the same to the superintending school committee of his respective city, town and plantation, so that the section as amended shall read :*

Laws of 1859, chap. 92, sect. 1, amended.

SECT. 1. The secretary of state shall, on the first day of March in each year, forward to the clerk of the several cities, towns and plantations, blanks for the annual school return, and registers for

Blank school returns, when and how distributed.

CHAP. 82. the school year commencing on the first day of April following; and said clerk shall forthwith deliver the same to the superintending school committee of his respective city, town and plantation.

SECT. 2. This act shall take effect when approved by the governor.

Approved February 18, 1867.

Chapter 82.

An act to increase the salary of the county attorney for the county of Aroostook.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Salary of co.
attorney of
Aroostook co.
established at
\$300.

SECT. 1. The annual salary of the county attorney for the county of Aroostook shall be three hundred dollars, payable quarterly, from the first day of January last, which shall be in full for all of his official services.

SECT. 2. This act shall take effect when approved by the governor.

Chapter 83.

An act to amend section fifty-two of chapter eleven of the revised statutes, relating to superintendents of schools.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

R. S., chap.
11, sect. 52,
amended.

Section fifty-two of chapter eleven of the revised statutes, is hereby amended by inserting in the fourth line, next after the word "dollar," the words *and fifty cents*, so that said section, as amended, shall read as follows :

Compensation
of superintend-
ing school
committee, &c.

SECT. 52. Superintending school committees and supervisors shall be paid for their services, on satisfying the municipal officers that they have made the returns to the secretary of state required by law, one dollar and fifty cents a day, and all necessary traveling expenses, and no more, unless ordered by the town.
