sociates and successors, are hereby incorporated by the name of Chap. 204. the Temiscouata Pine-land Company, with all the powers, rights Name, powers, and liabilities of corporations for similar purposes established by the laws of this state.

Sect. 2. Said corporation may hold property, real and personal, Capital. to an amount not exceeding five hundred thousand dollars, which may be put into shares of one hundred dollars each, which may be sold and transferred like other personal property, under such rules and by-laws as the corporation may adopt.

SECT. 3. The first meeting of said corporation for the purpose Organization. of organization may be called to be held in the city of Portland, by any three of the persons above named, by publishing notice thereof in any paper in the city of Portland, and the Boston Daily Advertiser, published in Boston, ten days before the day of said meeting.

SECT. 4. This act shall take, effect when approved by the governor.

#### Chapter 204.

An act to amend an act entitled "an act to incorporate the city of Angusta."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Sect. 1. The act incorporating the city of Augusta is hereby Members of amended by inserting in section four, after the word "year" in council the nineteenth line the words, none of whom shall be members of certain offices. the city council and.

- Sect. 2. All acts and parts of acts which are inconsistent with this act are hereby repealed.
- SECT. 3. This act shall take effect when approved by the governor.

### Chapter 205.

An act to increase the capital stock of the Lewiston Steam Mill Company in Lewiston.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Sect. 1. The Lewiston Steam Mill Company is hereby authorized and allowed to increase the capital stock of said corporation additional

capital and how divided.

CHAP. 206. by adding thereto the sum of fifty thousand dollars, to be divided into shares of one hundred dollars each.

> SECT. 2. This act shall take effect when approved by the governór.

#### Chapter 206.

An act to make valid the doings of the town officers of the town of Baldwin.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Doings of assessors in assessing taxes in 1863, made valid.

Sect. 1. The doings of the assessors of the town of Baldwin for the year of our Lord one thousand eight hundred and sixty-three, in assessing and committing all sums of money raised by and apportioned to said town as taxes for said year, are hereby declared and made valid and sufficient in law, notwithstanding any errors or omissions of said assessors in committing said taxes for collection.

Acts of collector legalized.

The acts of such person as was chosen collector of Baldwin for the year aforesaid, and to whom the tax bills of said town for said year were intrusted for collection, in collecting so much of said bills as by him has been collected, are hereby declared and made valid and sufficient in law, notwithstanding any errors or omissions by the assessors in the commitments for that year, or absence of collector's bond.

Assessors may abate taxes for said year, correct errors and recommit for collection.

- The assessors of the town of Baldwin for the time being, are hereby fully authorized to make such abatements in the taxes of said town for the year eighteen hundred and sixty-three, as they may deem proper, to correct any clerical errors, and to commit by warrant in due form of law all unpaid tax bills not so abated, for the year eighteen hundred and sixty-three, to any constable or collector of the town of Baldwin for collection.
- Sect. 4. This act shall take effect when approved by the governor.
