CHAP. 257.

SECT. 2. This act shall take effect when approved by the governor.

Chapter 257.

An act to incorporate the Matinicus Wharf and Dock Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. Henry Young, his associates, successors and assigns, are hereby incorporated into a company by the name of the Matinicus Wharf and Dock Company, and shall have all the rights and privileges, and be subject to all the duties and liabilities of similar corporations by the laws of the state.

SECT. 2. The said corporation shall have authority to build a wharf into tide waters from their own land, on the island of Matinicus, in a southerly direction to low water mark at low ebb, and make such piers or breastworks as they may deem necessary for their interest and the protection of said wharf or dock, and may make all needful rules and regulations for the government of the same, not repugnant to the laws of the state.

Chapter 258.

An act granting authority to Oliver M. Reynolds to construct wharves or weirs in Lubec.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Oliver M. Reynolds is hereby authorized to construct and maintain a wharf or wharves, fish-weir or weirs, in front of his land in the waters of Johnson's Bay, in the town of Lubec, within the limits of the width of his land at high water mark, extending into the waters of said bay forty rods from high water mark, in the same direction with the northeastern line of his land as it comes to the waters of said bay ; *provided* that no wharf or weir constructed as aforesaid, shall obstruct the usual navigation of said bay ; and that a sufficient number of poles shall be erected on said weir or weirs, with suitable signals thereon, to be not less than ten feet above the tide at high water.
