## Chapter 278.

An act to incorporate the Maine Ship-builders and Ship-owners Association.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Norris, together with such other persons as may join them, are hereby constituted a body corporate, to be known by the name of the Maine Ship-builders and Ship-owners Association.

Capital and purpose.

SECT. 2. Said association may take and hold property, real or personal, to an amount, the annual income of which, shall not exceed two thousand dollars, to be applied to the advancement of the interests of the ship-builders and ship-owners of Maine.

Organization.

SECT. 3. The first meeting of said association shall be called by any five of the said corporators by giving notice in one or more daily papers of the state for one week.

SECT. 4. This act shall take effect when approved by the governor.

Approved February 14, 1867.
