**Chapter 143.****CHAP. 143.**

Resolve laying a tax on the several counties in this state.

*Resolved*, That the sums annexed to the counties in the following schedule are hereby granted as a tax on each county respectively, to be appropriated, assessed, collected and applied for the purpose of paying the debts and necessary expenses of the same and other purposes ordered by law, to wit:—Androscoggin, nineteen thousand one hundred dollars; Aroostook, nine thousand one hundred and ten dollars; Cumberland, seventy-nine thousand one hundred and fifty dollars; Franklin, ten thousand dollars; Hancock, ten thousand three hundred and fifty dollars; Kennebec, twenty-seven thousand five hundred dollars; Knox, twelve thousand one hundred and sixty-three dollars and thirty-four cents; Lincoln, eight thousand five hundred dollars; Oxford, nine thousand dollars; Penobscot, thirty thousand dollars; Piscataquis, five thousand dollars; Sagadahoc, nine thousand dollars; Somerset, ten thousand dollars; Waldo, seventeen thousand dollars; Washington, fifteen thousand dollars; York, fifteen thousand dollars.

**Chapter 144.**

Resolve authorizing repairs upon the Houlton and Baring road.

*Resolved*, That the sum of six hundred dollars be, and the same is hereby appropriated to be expended under the direction of the land agent for repairing the Houlton and Baring road, as follows, viz:—One hundred dollars upon the road leading through township number eleven, range one at the Monument, and five hundred dollars upon that part of the road leading through Indian township.

**Chapter 145.**

Resolve authorizing a conveyance of land to H. B. Hersey.

*Resolved*, That the land agent be authorized to convey to H. B. Hersey, the south half of section number fifty in township numbered four in the fifth range, west east line of state, in consideration of the usual requirements of a settler, excepting a residence thereon.
