**Chapter 163.**

CHAP. 163.

Resolve in favor of William W. Quimby of Bucksport.

*Resolved*, That there be paid from the state treasury to William W. Quimby of Bucksport, in the county of Hancock, the sum of four dollars per month, three years ensuing, dating from the first day of January, in the year of our Lord eighteen hundred and sixty-seven.

**Chapter 164.**

Resolve in favor of Adam Richardson.

*Resolved*, That there be paid out of any money in the treasury not otherwise appropriated, to Adam Richardson, the sum of thirty-four dollars as compensation in full for all claim against the state under the provisions of an act concerning contagious diseases among cattle, approved March nineteen, eighteen hundred sixty-two, for loss of a cow by a contagious disease in the year eighteen hundred sixty-five.

**Chapter 165.**

Resolve relating to the assassination of John King Robinson at Salt Lake City.

WHEREAS, the circumstances attending the violent death of Dr. John King Robinson at Salt Lake City, in the Territory of Utah, show conclusively that he was assassinated by a band of Mormons acting under the direction of the leading authorities of that people, who had become hostile to him on account of the position he had taken in refusing to comply with their practices and customs and in aiding to establish a congregational sabbath school in Salt Lake City; and whereas, the said John King Robinson was a native of the State of Maine and remained a citizen thereof until his removal to Utah territory; and whereas, the continuance of the Mormon power in Utah renders unsafe all citizens of the United States in that territory who desire liberty of conscience and freedom to pursue honorable employments such as can be enjoyed in other states and territories, and fixes upon our nation the reproach of polygamy, therefore, as an expression of the legislature of Maine, be it

judgment may be most efficient to induce the administration to assume control of affairs in Utah so that the safety of citizens of the United States therein may be insured, and polygamy in that territory abolished at as early day as may be practicable.

*Resolved*, That the governor of this state is requested to forward a copy of these resolves to each of the senators and representatives in congress from Maine.

### Chapter 166.

Resolve in favor of Albert Cushman.

*Resolved*, That there be paid out of any money in the treasury not otherwise appropriated to Albert Cushman, the sum of seventy dollars as compensation in full for all claim against the state under the provisions of an act concerning contagious diseases among cattle, approved March nineteen, eighteen hundred sixty-two, for isolation and loss of stock, and damages by reason of a contagious disease with which his cattle were infected in the year eighteen hundred sixty-five.

### Chapter 167.

Resolve in favor of the eastern normal school.

Normal school  
at Castine, in  
favor of.

*Resolved*, That the sum of three thousand two hundred dollars be and the same is hereby appropriated, to be paid annually for the term of three years from the treasury of state, for the support of the eastern normal school at Castine, to be expended under the direction of the governor and council, and the first of said annual appropriations shall be paid for the use of said school on or before September first, eighteen hundred sixty-seven; *provided* that the people of Castine shall first comply with the conditions upon which the said normal school was located there by resolve of last year; and the governor is hereby authorized to draw his warrant upon the state treasurer for the above money.
