Chapter 184.

An act to repeal an act entitled "an act to amend section four of chapter thirty-four of the revised statutes, relating to auctions and auctioneers."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. Chapter one hundred and eighty-eight of the public Public laws of laws of eighteen hundred and sixty, relating to auctions and auc- 1860, chap. 188, repealed. tioneers, is hereby repealed.

This act shall take effect when approved.

Chapter 185.

An act giving certain powers to the commissioners of fisheries.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. During the continuance in force of chapter seventyeight of the resolves of eighteen hundred sixty-seven, entitled examine dams "resolve relative to the restoration of sea fish to rivers and inland waters of Maine," the commissioners appointed under said resolve may, at their discretion, on petition of three or more responsible persons, exercise the powers granted to county commissioners in under chap. 78 sections twenty-two, twenty-three and twenty-four of chapter forty of resolves of 1867. of the revised statutes, and the proceedings shall be as provided in said sections; but this act shall not be so construed as to give the commissioners any other pay than that derived from the resolve continuing in force chapter seventy-eight of the resolves of eighteen hundred sixty-seven.

Authority to and order erection of fishways, conferred on commissioners appointed

This act shall take effect when approved.
