**Chapter 418.**CHAP. 418.

An act to incorporate the C. P. Kimball Company of Portland.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. J. M. Churchill, George F. Shepley, A. K. Shurtleff, J. S. Ricker, Joseph Walker, C. P. Kimball, John M. Gould, James Bailey, Eben Corey, Bion Bradbury, Wm. E. Gould, L. D. M. Sweat, A. A. Strout, S. E. Spring, A. Spring, J. B. Brown, P. H. Brown, N. A. Foster, Charles S. Forbes, H. H. Burgess, Joshua Waterhouse, J. B. Cummings, Thomas Cummings, N. M. Perkins, W. W. Harris, J. R. Corey, E. D. Gammon, W. H. Woodbury, with their associates and successors, are hereby constituted a body politic and corporate, by the name of the C. P. Kimball Company, with a capital stock of fifty thousand dollars, divided into shares of one hundred dollars each, with power to increase the capital stock to one hundred thousand dollars, by a vote of the stockholders representing two-thirds of the stock, and they are hereby authorized to purchase and hold real and personal estate to the amount of their capital stock, to erect such buildings as they may require for the purpose of manufacturing carriages and sleighs in the city of Portland, and shall have all the powers and privileges, and be subject to all the duties and requirements expressed in the laws of the state relating to manufacturing corporations.

SECT. 2. Any two of the persons named in this act may call the first meeting of said corporation by giving written notice to each of the corporators at least five days prior to the time of said meeting.

Organization.

**Chapter 419.**

An act to make valid the doings of school district number five, in the town of Robbinston.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. The doings of school district number five, in the town of Robbinston, at a meeting held on the twenty-third day of August, in the year of our Lord one thousand eight hundred and sixty-six. Also the doings of said district at an adjourned meeting held September eighth, in the same year, are hereby made valid.

SECT. 2. This act shall take effect when approved.
