## CHAP. 446.

**Chapter 446.**

An act to authorize Frederick J. Alley to construct a fish weir in Frenchman's bay, in Eden.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Location.

Limits and conditions of extension.

SECT. 1. Frederick J. Alley shall have the privilege, and is hereby authorized to erect and maintain a fish weir in the tide waters of Frenchman's bay, in front of his own land, in the town of Eden: *provided*, that such fish weir shall be erected within the limits of an extension of the side lines of his lot, forty rods northerly from high water mark, and that such weir shall not be so constructed as to obstruct the navigation of Frenchman's bay, or to interfere with the rights of riparian owners.

SECT. 2. This act shall take effect when approved.

**Chapter 447.**

An act to incorporate the Casco Preserving Company.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Corporators.

Purpose.

Location.

Capital.

Corporate property.

Organization.

SECT. 1. Samuel F. Perley, Isaac McLellan, D. W. Clark, H. M. Payson, Lewis McLellan, Josiah B. Webb, Joseph Walker, and their associates, heirs and assigns, are hereby constituted a body politic and corporate, by the name of the Casco Preserving Company, having for its object the preservation of fruits and other organic substances, beyond the usual period of their keeping, under patents of Prof. B. M. Nyce, and their place of business shall be Gorham, and such other places in the county of Cumberland as may be deemed desirable.

SECT. 2. The capital stock of said company shall not be less than twenty thousand dollars; divided into shares of one thousand dollars each, and may be increased at any time hereafter by vote of the said company, to any sum not exceeding one hundred thousand dollars.

SECT. 3. Said corporation may purchase and hold real estate, to an amount not to exceed one-half of the amount of their capital stock.

SECT. 4. Either of the persons herein named as corporators may call the first meeting of the corporation, by giving seven days' personal notice thereof to the other corporators.

SECT. 5. This act shall take effect when approved.
