**Chapter 506.**

An act to incorporate the Pejepscoot Mining Company.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. E. K. Harding, S. D. Bailey and H. S. Osgood, their Corporators.  
 associates and successors, are hereby constituted a body politic and corporate, by the name of the Pejepscoot Mining Company, with power to adopt a common seal, to sue and be sued, to acquire Powers, &c.  
 and hold real and personal estate, and to lease, sell and convey, or otherwise dispose of the same, to adopt a code of by-laws not inconsistent with the laws of this state, and to do and perform such other acts and things as may be necessary for the successful prosecution of the business of said corporation.

SECT. 2. The capital stock of said corporation shall consist of Capital.  
 eighty-five thousand shares, of the par value of five dollars for each share.

SECT. 3. The first meeting of said corporation for the choice of Organization.  
 officers may be called to be held at Bath, by either of the persons named in this act, by giving notice in writing to each of the other corporators of the time and place of such meeting, and until such officers are thus chosen the powers of said corporation may be exercised by the three persons above named, who may for the time being act as directors of said company, and a majority of whom shall constitute a quorum for the transaction of business.

SECT. 4. This act shall take effect when approved.

**Chapter 507.**

An act to amend an act to incorporate the Knox County Fire Insurance Company.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. The title of said act is hereby amended, by striking Amended by  
change of cor-  
porate name.  
 out the word " Fire," and inserting the word ' Marine,' so that it shall read ' Knox County Marine Insurance Company.'

SECT. 2. Section first of said act is hereby amended, by striking out the word " Fire," in the seventh line of said section, and inserting the word ' Marine,' so that it shall read ' Knox County Marine Insurance Company.'

SECT. 3. This act shall take effect when approved.
