**CHAP. 527.**

Executions.

court, which shall have authority to issue executions to be satisfied in the same manner as though issuing from the supreme judicial court, except that no such execution shall be levied on real estate, unless the debt or damage therein shall exceed the sum of twenty dollars.

Trial justices may take cognizance of cases when judge or recorder are parties interested.

Certain provisions in former acts repealed.

SECT. 17. Any trial justice in the city of Calais may take cognizance of any action, matter or thing within their jurisdiction, wherein the judge or recorder of said municipal court of the city of Calais is a party or interested.

SECT. 18. Sections twelve, thirteen and fourteen of said act incorporating the city of Calais, also an act to amend an act entitled "An act to incorporate the city of Calais," approved April nineteenth, in the year of our Lord one thousand eight hundred and fifty two, are hereby repealed.

**Chapter 527.**

An act to make valid the acts of the selectmen and assessors of the town of Leeds.

*Be it enacted by the Sena'e and House of Representatives in Legislature assembled, as follows :*

Acts of town officers for 1867 made valid.

SECT. 1. The acts of the selectmen, assessors and overseers of the poor of the town of Leeds for the year eighteen hundred and sixty-seven are hereby declared valid ; and the assessment of all taxes by said selectmen, assessors and overseers, and all other acts in their official capacity, whether performed by only two of said board, and without the taking of the necessary oath of office by any member of said board of selectmen, assessors and overseers of the poor aforesaid.

SECT. 2. This act shall take effect when approved.

**Chapter 528.**

An act to amend section two, chapter two hundred and nine, private and special laws of eighteen hundred and sixty-seven, entitled "An act to incorporate the Hinckly Knitting Machine Company."

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. Section two, chapter two hundred and nine of private and special laws of eighteen hundred and sixty-seven, is hereby

amended by striking out the word Biddeford and inserting the word, 'Bath.'

Biddeford to Bath.

SECT. 2. This act shall take effect when approved.

**Chapter 529.**

An act to increase the pay of the sheriff of the county of Aroostook.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. The pay of the sheriff of Aroostook county, shall hereafter be three hundred dollars annually, commencing January first, eighteen hundred and sixty-eight, instead of one hundred and and twenty-five dollars, as provided in chapter eighty, section twenty-one of the revised statutes.

Salary to be \$300 per annum.

SECT. 2. This act shall take effect when approved.

**Chapter 530.**

An act to regulate the service of grand jurors in the county of Lincoln.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. The persons who shall be impanelled as grand jurors at the first term of the supreme judicial court in the county of Lincoln, in the year eighteen hundred and sixty-eight, shall serve as such at that term and no longer ; and the venire next to be issued for grand jurors in said county, under the provisions of section eight of chapter one hundred and six of the revised statutes, shall be made returnable at the term of said court, to be held in said county, on the fourth Tuesday of October in the same year.

Limitation of service at first term S. J. C. in 1868.

Venires next issued for grand jurors made returnable at October term.

SECT. 2. This act shall take effect when approved.

Approved February 18, 1868.
