Chapter 552.

An act to renew the charters of certain banks.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. The charters of the Veazie Bank, the Eastern Bank, Banks. the Farmer's Bank, the Mercantile Bank, all of Bangor, and the City Bank of Bath, are hereby extended to the first day of Octo- Charter extendber, in the year of our Lord one thousand eight hundred and ed to Oot. 1, 1870. seventy, subject to all the provisions of existing laws upon the subject of banks and banking; provided however, that said banks Proviso as to shall not be required to pay the state tax heretofore imposed so state tax. long as they shall be compelled to pay a tax on their circulation under any act of congress.

SECT. 2. Any bank mentioned in the preceding section may Provisions accept the provisions thereof extending their charters at a special meeting of the stockholders called for that purpose, held on or be- stockholders. fore the first day of August next, by two-thirds votes cast on a stock vote, and if said provisions are accepted, written notice Notice of same thereof shall be given to the secretary of state on or before the to georetary of first day of September next.

Chapter 553.

An act to incorporate the Bath Marine Insurance Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. Edward Sewall, H. L. Houghton, James T. Patten, Corporators. John Harward, S. D. Bailey, C. V. Minot, S. T. Woodward, J. H. Kimball, J. C. Jameson, H. W. Swanton, J. H. Allen, Albert Hathorn, Charles Clapp, Jr., M. F. Gannet, Jarvis Patten, and their associates, successors and assigns, are hereby created a corporation by the name of the Bath Marine Insurance Company, to Name and be established at Bath, in the county of Sagadahoc, with power location. and authority to transact the business of marine insurance, and to provide, by the by-laws of said company, for the appointment of Powers. all necessary and proper officers for the management of the business of said company, and to regulate the business of said company by proper by-laws, conformable with the laws of the state.

SECT. 2. The first meeting of said corporation shall be called Organization. by a written notice signed by three of said corporators, and published at least five days before the day of meeting, in the Bath daily newspaper,
