### Chapter 593.

An act to repeal an act entitled "An act to incorporate the town of Glenwood."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Repeal of act of incorporation.

Proviso as to prosecution and defence of suits.

Proviso as to payment of judgments and taxes. SECT. 1. An act entitled "An act to incorporate the town of Glenwood," approved the fourteenth day of February, in the year of our Lord one thousand eight hundred and sixty-seven, is hereby repealed; *provided however*, that the corporate existence, powers, duties and liabilities of said town shall survive for the purpose of prosecuting and defending all pending suits and causes of suits to which said town is or may be a party, and all needful processes growing out of the same; and for the further purpose of providing for the payment of all or any judgments which may be recovered against said town, and shall also be held to pay their proportion of the state tax for the year eighteen hundred and sixty-eight.

SECT. 2. This act shall take effect when approved.

### Chapter 594.

An act to incorporate the Portland Water and Gas Pipe Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

of Portland, and to purchase real and personal estate not exceeding
