#### Chapter 189.

Снар. 189.

Resolve authorizing the land agent to convey a lot of land to the heirs of the late John Mathison.

Resolved, That the land agent be, and he is hereby, authorized C. W. Mathito convey to C. W. Mathison, Lydia Burgoin and Margaret Mathison, heirs of the late John Mathison, the lot of land in township number nine, range five, W. E. L. S., being the homestead of said favor of. Mathison, as the same was run out by Massachusetts in eighteen hundred thirty-nine, and eighteen hundred sixty-four by the agent of the late David Pingree; reserving, however, the timber and lumber upon said lot, that having been contracted for by said Pingree with Massachusetts; the soil, in this case, only intended to be conveyed.

Resolved, That by reason of the inability of John H. Converse, Adjournment esquire, judge of probate within and for the county of Lincoln, to of court during hold a regular session of the probate court for said county, ap- judge. pointed to be held at Wiscasset on the first Tuesday of February next, the register of probate for said county is hereby authorized and empowered, so long as such inability continues, to adjourn said court from time to time, and to such time and place within said county as said judge of probate may by his written order designate, by posting notice thereof at the probate office.

Resolve for the distribution of books to the judges of the courts of the United States in this district

Resolved, That the secretary of state be, and he is hereby, Judges U.S. directed to furnish each of the judges of the circuit and district district and district district and courts of the United States for this state, for the use of said judges and their successors in office, a copy of the statutes and and reports. laws of the state, and decisions of the supreme court; provided the same are now on hand; and they shall each be entitled to a copy of the laws and reports, from time to time, as published.
