**Chapter 268.**

CHAP. 268.

Resolves to continue in force and amendatory of chapter seventy-eight of the resolves of eighteen hundred and sixty-seven, in relation to the restoration of sea fish to the rivers and inland waters of Maine.

*Resolved*, That chapter seventy-eight, a resolve approved January twenty-eight, eighteen hundred and sixty-seven, relative to the restoration of sea fish to the rivers and inland waters of Maine, be and hereby is continued in force for the term of two years, subject to the amendment hereafter provided.

Ch. 78 resolves of 1867, continued in force.

*Resolved*, That chapter seventy-eight of the resolve approved January twenty-eight, eighteen hundred and sixty-seven, be amended, by striking out in the second resolve, after the words "the sum of," the words "one thousand dollars," and insert the words 'fifteen hundred dollars annually,' so that the sentence shall read, 'provided the expense does not exceed the sum of fifteen hundred dollars annually.'

Amendment of said chapter.

*Resolved*, That the commissioners appointed under this resolve make an annual report to the governor and council, who shall cause one thousand copies of the same to be printed for distribution.

Report of commissioners.

Approved March 6, 1868.

**Chapter 269.**

Resolve in favor of Pillsbury and Smith.

*Resolved*, That there be paid out of the treasury of the state, from any money not otherwise appropriated, the sum of seventy-two dollars and eight cents, the same being for two hundred copies of the Maine Standard furnished to the legislature during the present session, by order.

Pillsbury and Smith, in favor of.

Approved March 6, 1868.

**Chapter 270.**

Resolve in favor of the insane asylum.

*Resolved*, That the trustees of the insane hospital are hereby authorized to procure a survey and plan of the sewer and water pipes of the insane hospital, and that the governor is hereby authorized to draw his warrant on the state treasurer for an amount not exceeding fifty dollars to pay for the same.

Insane asylum, in favor of.
