BARNARD SLATE QUARRY COMPANY .-- MERIDIAN HALL CO.

Chapter 98.

An act to incorporate the Barnard Slate Quarry Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Corporators.

Corporate name.

May hold and dispose of real and personal

Rights and privileges.

Purpose,

First meeting, how called.

Capital stock; shares.

Thomas N. Egery, William Williams and F. F. French, SECT. 1. and their associates, successors and assigns, are hereby created and constituted a body politic and corporate, by the name of the Barnard Slate Quarry Company, and by that name may sue and be sued, adopt a common seal and alter the same at pleasure, may purchase, lease, rent, hold, hire, pledge and dispose of real and personal property deemed necessary for the uses and purposes of said company to an amount not exceeding one hundred thousand dollars, and in general to have and exercise all such other rights, powers, facilities and privileges as now appertain to manufacturing corporations in this state, and such as may be necessary and proper for the purpose of mining, quarrying, manufacturing and vending slate.

SECT. 2. The first meeting of this corporation shall be called by Thomas N. Egery, by notice in writing to each other corporator named, given at least five days prior to the time of said meeting.

SECT. 3. Said corporation may divide their original stock into such number of shares, and provide for the sale and transfer thereof in such manner and form as said corporation shall from time to time determine, not repugnant to the laws of this state.

SECT. 4. The office of said company shall be at Bangor in the county of Penobscot, and there all books of record and transfer shall be kept. The secretary of said company shall reside at Bangor, and a majority of the directors shall reside in this state. SECT. 5. This act shall take effect when approved.

Chapter 99.

An act to incorporate the Meridian Hall Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

and assigns, are hereby constituted a body politic and corporate CHAP. 100. by the name of the Meridian Hall Company, with power to sue Corporate name. and be sued, adopt a common seal and make by-laws not inconsistent with the laws of this state.

The capital stock of said corporation shall be twenty Capital stock. SECT. 2. thousand dollars, to be divided into shares of twenty-five dollars each, and every shareholder shall be entitled to as many votes by himself or proxy as he holds shares, at any meeting of said corporation.

An act to incorporate the Houlton Savings Bank.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Madigan, their associates and successors, are hereby constituted a body politic and corporate, by the name of the Houlton Savings Bank, with power Corporate name. by that name to prosecute and defend suits at law and equity, Power. have and use a common seal, make by-laws for the management of their concerns not repugnant to the laws of the state. Said Location. corporation shall be established in the town of Houlton with the Rights and right to exercise and enjoy all the rights and privileges incident to such corporations.

Said corporation may receive from any person or Deposits, how SECT. 2. persons any deposit or deposits of money and may use the same for purposes hereinafter provided.

SECT. 3. All deposits of money received by said corporation shall be used as they shall judge most for the benefit of said corporation, and the net income or profit thereof shall be by them Profits, how divided. divided among the persons making such deposits, their executors,
