Chapter 39.

Resolve in favor of owners of lands taken by the United States and ceded to Great Britain.

Claims of owners of lands, investigation of by governor and council. Resolved, That the governor and coucil are hereby authorized to investigate the claims of the several owners of lands on the north-eastern boundary of the state, between the monument and the river St. John, taken from them and ceded to Great Britain, by the treaty of Washington, and allow to each of the owners, or their assigns, a just compensation for their several proportions thereof, and take all necessary measures to obtain such amount or amounts from the United States, and when the same shall be allowed by the United States the governor shall draw his warrant on the treasurer for the sums due the several persons.

Chapter 40.

Resolve authorizing the land agent to designate certain lots as public lets in lieu of other lots.

Land agent authorized to designate certain public lots in lieu of others. Resolved, That the land agent be, and he is hereby authorized to designate and set apart lots numbered one hundred and eight, one hundred and sixteen, one hundred and twenty-four, one hundred and thirty-two, and one hundred and forty, as reserved lots, in Chapman plantation, in the county of Aroostook, in lieu of lots numbered one hundred and twelve, one hundred and twenty, one hundred and twenty-eight, one hundred and thirty-six, and one hundred and forty-four, in said plantation, if in his judgment it will be for the interest of the settlement in said plantation to make such designation.

Chapter 41.

Resolve abating state taxes on township number eighteen, range five, Aroostook county.

Abatement of state tax.

Resolved, That the state treasurer be, and he hereby is authorized and directed to abate the state taxes assessed upon township number eighteen, range five, Aroostook county, for the years eighteen hundred sixty-six, eighteen hundred sixty-seven, and eighteen hundred sixty-eight, amounting to the sum of seventy-nine dollars fifty-five cents. Said abatement is made in conse-

quence of said township having been assessed for state taxes, for Chap. 42. the above years, as Dionne plantation.

Chapter 42.

Resolve in favor of the joint standing committee on state reform school.

Resolved, That the state treasurer is hereby authorized and committee on directed to pay to Marquis D. L. Lane the sum of forty-six dol- in favor of. lars, it being for actual expenses incurred by the committee visiting the state reform school, on the twenty-eighth day of January last.

Chapter 43.

Resolve in favor of Joseph Fields, Jones Bisbee and B. J. Hines.

Resolved, That there be paid out of any money in the treasury, Appropriation not otherwise appropriated, to Joseph Fields the sum of ninetythree dollars, to Jones Bisbee the sum of fifty-two dollars, to B. J. Hines the sum of fifty-six dollars, as compensation in full for all claim against the state, under the provisions of an act concerning contagious diseases among cattle, approved March nineteenth, eighteen hundred sixty-two, for loss of cattle by contagious disease, in the year eighteen hundred sixty-seven.

Chapter 44.

Resolve in favor of the joint standing committee on the state prison.

Resolved, That the state treasurer is hereby authorized and Committee on directed to pay George Goodwin the sum of one hundred and favor of. forty-five dollars and fifty cents, it being for expenses incurred by the committee visiting the state prison, the third day of February, eighteen hundred sixty-nine.
