#### EAST OXFORD AGRICULTURAL SOCIETY.

Said company may make, establish and put in execu- CHAP. 699. Sect. 2. tion such by-laws, not contrary to the laws of the state, as may By-laws. seem necessary or convenient for the regulation and management of its affairs, and do and execute all such acts as may be necessary to carry into effect the purposes intended by this act.

SECT. 3. The first meeting may be called by any three persons First meeting, named in this act, by posting up in three public and conspicuous places, in said towns of Poland and Minot, notice of the time and place at least ten days before such meeting, at which time and place the members present may elect all needful officers, fix their officers and their compensation and manage their own affairs in any way not repugnant to the general laws of this state relating to such companies.

SECT. 4. This act shall take effect when approved.

#### Chapter 699.

An act to amend "an act to incorporate the East Oxford Agricultural Society."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. Section two of said act, is hereby amended, by adding Amended. after the word "Upton" the word 'Carthage,' so that said section, as amended, shall read as follows: 'Said society is hereby society estabestablished within the towns of Canton, Livermore, Hartford, Limits, Peru, Dixfield, Rumford, Mexico, Roxbury, Byron, Andover, Grafton, Newry, Hanover, Upton, Carthage, and all the plantations lying in the northerly portion of said county, and may take May hold real or and hold property, real or personal, the annual income of which shall not exceed one thousand dollars, to be applied to the advancement of agricultural and mechanical arts.'

SECT. 2. Section three of said act, is hereby amended, by add- Section three ing at the end thereof the following words: 'And said society is hereby authorized to locate in any of the towns named in section two,' so that said section, as amended, shall read as follows: 'This society shall have all the powers and privileges, and be Powers and privi subject to all the liabilities and restrictions, usually granted to and restrictions. and imposed upon similar societies, and said society is hereby authorized to locate in any of the towns' named in section two.'

This act shall take effect when approved. SECT. 3.
