JAIL AND HOUSE OF CORRECTION, YORK COUNTY.

Magalloway river, between Ezcohos falls and Parmachene lake, with all the rights and privileges and subject to all the duties, Location of obligations and liabilities contained and set forth in said act of and liabilities. incorporation.

SECT. 2. This act shall take effect when approved.

Chapter 53.

An act in relation to building a jail and house of correction in the county of York.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

The county commissioners of the county of York are Jali, erection of, authorized. Sect. 1. hereby authorized to contract for the erection and completion of a jail and house of correction in and for the county of York, to be located at Alfred in said county, sufficient and suitable for said Location. purposes, provided the same can be done at a cost and expendi- Proviso. ture not exceeding the sum of thirty thousand dollars in the whole, not including foundation, &c., named in section three of this act; such buildings to include suitable accommodations and outbuildings for the keeper of said jail and house of correction, which jail and house of correction is to be built according to plans and specifications prepared and provided by said commissioners, and the fulfilment and completion of the work under said contract shall be Contract. secured by bond with good and sufficient sureties.

SECT. 2. After the contract above mentioned has been made and secured as above provided and for purposes above mentioned, the treasurer of York county is hereby authorized to procure by loan a sum not exceeding twenty-five thousand dollars, to be paid Loan authorized. out under direction of said commissioners as the work on said buildings under said contract progresses, the interest on said loan Interest and printo be paid semi-annually and the principal at such time, not exceeding ten years, as said commissioners may determine, and the said treasurer is hereby authorized to issue county bonds therefor with coupons for interest attached payable in manner aforesaid.

Said county commissioners are hereby authorized to **Sect.** 3. use any and all of the materials of the present jail with present foundation stones on new lot and new lot and also proceeds of the sale of the county house and lot and all buildings contained thereon at Alfred, in the construction of said new jail and house of correction, and to sell and convey by sufficient deed thereof the county house and lot at said Alfred.

SECT. 4. This act shall take effect when approved.
