**Chapter 94.**

An act to amend the charter of the Saco River Railroad Company.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Authorized to elect corporators.

SECT. 1. That the corporators named in the first section of an act incorporating the Saco River Railroad Company, approved March five, eighteen hundred and sixty-nine, be authorized to elect other corporators who shall have the same powers with themselves and be subject to the same liabilities.

Time of location and completion of, extended.

SECT. 2. The time for the location of said railroad is hereby extended to March one, eighteen hundred and seventy-five, and the time for its completion to March one, eighteen hundred and seventy-seven.

SECT. 3. This act shall take effect when approved.

**Chapter 95.**

An act to prevent the use of narrow rimmed wheels on the roads of the towns of Addison and Columbia.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Rim of wheels, breadth, prescribed.

SECT. 1. No person or persons shall haul or cart lumber or ship timber over or on the roads of the towns of Addison and Columbia with a team of more than two horses or two oxen, upon wheels of less than five inches tread or breadth of rim, nor with a team of two horses or two oxen upon wheels of less than four inches tread or breadth of rim.

Penalty for violation.

SECT. 2. If any person shall violate the provisions of the foregoing section, he shall forfeit and pay ten dollars, one-half to the use of the person suing therefor and one-half to the use of the county of Washington, to be recovered in an action of debt or an action on the case, before any court of competent jurisdiction.

Trial justices to have jurisdiction of, in case of violation.

SECT. 3. Trial justices of the towns of Addison and Columbia shall have jurisdiction for the trial of cases named in section two of this act arising in their towns, in the same manner and to the same extent as if not residents of said towns.

SECT. 4. This act shall take effect on the first day of July, in the year of our Lord one thousand eight hundred and seventy-two.
