Chapter 113.

An act to incorporate the Augusta Trotting Park Association.

Be it enacted by the Senate and House of Representatives in Legislature assembled. as follows:

Thomas S. Lang, Whitman M. Thayer, Ira D. Sturgis, Corporators. **Sect.** 1. Owen C. Whitehouse, Henry A. DeWitt, J. Manchester Haines, Henry S. Osgood, and Israel Boothby, of Augusta, their associates, successors and assigns, are hereby created a body politic and corporate by the name of the Augusta Trotting Park Asso- corporate name. ciation, with power to construct, maintain and use a trotting park Powers, &c. in the city of Augusta, and by that name shall have power to prosecute and defend suits at law, to have a common seal and to seal. change the same at pleasure, and to take, hold and convey for the objects of their association any estate, real or personal, the annual May hold real income of which shall not exceed five thousand dollars; and they are hereby invested with all the powers and privileges incident to similar corporations.

SECT. 2. Said association may adopt, from time to time, such Rules, regularules, regulations and by-laws, not repugnant to the constitution and laws of this state, and may choose such officers as they shall deem expedient for the proper management of their affairs.

SECT. 3. The stock of this corporation shall be divided into Shares. forty shares, at a par value of fifty dollars each.

SECT. 4. Stockholders shall have one vote for each share owned votes. and held, on which all assessments have been paid.

The first meeting of said association shall be called First meeting, SECT. 5. by Thomas S. Lang, or either of the persons named in the first section, by sending a written notice to the other corporators of the time and place of such meeting at least seven days before such time arrives.

SECT. 6. This act shall take effect when approved.

Chapter 114.

An act additional to "An act to incorporate the city of Lewiston," relating to election of assessors and overseers of the poor.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. At the first appointment and election of assessors and Assessors and overseers of the poor for the city of Lewiston, hereafter made and election and term held, one of each of said boards of assessors and overseers of the poor shall be appointed, elected and designated to serve one year,
