Chapter 50.**CHAP. 50.**

Resolves in favor of the state prison.

Resolved, That the sum of six thousand dollars for purchase of land, extension and rebuilding of wall, enlargement of blacksmith shop and paint shop, repairs of warden's residence and other buildings, also nine thousand dollars for increase of working capital, making in all fifteen thousand dollars, be and hereby is appropriated for the benefit of the state prison.

State prison, in favor of.

Resolved, That the warden of the state prison with the advice of the inspectors and approval of the governor and council, be and hereby is authorized to sell and convey certain lands and granite quarries owned by the state prison, and to convert the proceeds thereof to the use of the prison.

Warden authorized to sell certain lands.

Approved February 24, 1872.

Chapter 51.

Resolve in favor of Arathusa Littlefield.

Resolved, That there be paid from the state treasury to Arathusa Littlefield, of Wells, York county, wife of Horace P. Littlefield, a pension of eight dollars per month, to commence January first, eighteen hundred and seventy-two, it being for the support of the family of said Horace P. Littlefield, a soldier of the war of eighteen hundred and sixty-one and now insane.

Arathusa Littlefield, in favor of.

Chapter 52.

Resolve to amend a resolve, approved March seventh, eighteen hundred and seventy, regulating the number and pay of clerks in the several departments.

Resolved, That a resolve approved March seventh, eighteen hundred and seventy, is hereby further amended by adding after the words "state treasurer" in the third line of said resolve, the words 'state librarian,' so that the resolve as amended shall read as follows :

Pay of clerks, in relation to.

Resolved, That the number of clerks to be employed by the adjutant general, secretary of state, land agent, state superintendent of common schools, state treasurer and state librarian, shall be determined by the governor and council, who shall fix their compensation.

Number and compensation of, how determined.
