Luther B. Rogers,

in favor of.

Chapter 72.

Resolve in favor of Luther B. Rogers.

Resolved, That the land agent be and he is hereby authorized and directed to convey by deed to Luther B. Rogers, the southeast quarter of section or block numbered thirty-seven in Crystal plantation, county of Aroostook, waiving futher settling duties.

Chapter 73.

Resolve relating to fencing the normal school grounds in Farmington.

Resolved, That the sum of four hundred dollars be, and is hereby appropriated for the erection of a fence to protect the grounds of the state normal school in the town of Farmington, to be expended under the direction of the governor and council.

Chapter 74.

Resolve in aid of building a bridge over Dead river in the county of Somerset.

Resolved, That the sum of one thousand dollars be and the same is hereby appropriated in aid of building a bridge over Dead river at Flagstaff, in the county of Somerset; *provided* said bridge shall be completed to the satisfaction of the land agent before said sum shall be paid by the state, and this sum when paid shall be in full.

Chapter 75.

Resolve in favor of Rodney C. Barker.

Resolved, That the land agent be and he is hereby authorized to sell to Rodney C. Barker lot numbered one hundred and one, in

township numbered four, range four, west from the east line of the CHAP. 76. state; provided said Barker shall have paid for the same in road labor at fifty cents per acre, within one year from the approval of this resolve, waiving further settling duties.

Chapter 76.

Resolve in favor of the Children's Home in Bangor.

Resolved, That there be paid out of any moneys in the treasury not otherwise appropriated, the sum of two thousand dollars to favor of. the trustees of the Children's Home in Bangor, and the governor is authorized to draw his warrant on the treasury therefor.

Chapter 77.

Resolve in favor of Arthur L. Grant of Hermon.

Resolved, That there be paid to Arthur L. Grant of Hermon, in Arthur L. Grant. the county of Penobscot, out of any money in the treasury not otherwise appropriated, the sum of four dollars per month, commencing on the first day of January, eighteen hundred and seventy-two, and continuing during the pleasure of the legislature.

Chapter 78.

Resolve in favor of Charles W. Owen, minor child of the late Eben F. Owen.

Resolved, That a pension at the rate of eight dollars per month Charles W. Owen, for the term of three years, commencing on the first day of January, in the year of our Lord eighteen hundred and seventy-two, to be paid semi-annually, out of any money in the treasury not otherwise appropriated, be granted to Charles W. Owen, minor child of Eben F. Owen, deceased, late a private in company K, of the ninth regiment of Maine volunteers.
