Chapter 277.

Снар. 277.

An act to extend the time for the location and completion of the Bridgton Branch Railroad.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. Chapter five hundred and four of the private laws of charter revived. eighteen hundred and seventy, entitled "An act to incorporate the Bridgton Branch Railroad," is hereby revived and continued in force, and the time of the location of said road is hereby ex- Location and tended to July first, in the year of our Lord one thousand eight extended. hundred and seventy-four, and the time for the completion of the same, to July first, in the year of our Lord one thousand eight hundred and seventy-six.

This act shall take effect when approved. SECT. 2.

Approved February 14, 1873.

Chapter 278.

An act to incorporate the Paris Mutual Fire Insurance Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. H. N. Bolster, E. F. Stone, S. R. Parsons, D. B. Corporators. Sawyer, B. F. Twitchell, A. B. Andrews, A. Bennett, William Rice, L. Hill, Leonard Shurtleff, J. D. Williams, Horatio E. Swasey, Henry R. Parsons, C. B. Knight, Charles Morse, David N. True, G. G. Phelps, Jere Winslow, A. Hersey, E. H. Haskell, William A. Frothingham, Kendall Swift, N. D. Bolster, and all others who may hereafter become members of said company, are hereby incorporated and made a body politic by the name of the Paris Mutual Fire Insurance Company, for the purpose of insuring Corporate name in the town of Paris only, their respective dwelling houses, stores. shops, barns and other buildings, household furniture and merchandise, against loss or damage by fire, whether the same happen by accident, lightning or by any other means excepting that of design in the insured; and may purchase and hold such real and May hold real personal estate as may be necessary to effect the object of their estate. association, and may sell and convey the same at pleasure.

SECT. 2. Said company may make, establish and put in execu- By-laws. tion such by-laws not contrary to the laws of the state as may seem necessary or convenient for the regulation and management of its affairs, and do and execute all such acts as may be necessary to carry into effect the purposes intended by this act.
