CHAP. 101.

Chapter 101.

Resolve providing for the purchase of the Maine state year book and legislative manual.

Me. state year
book, contract
for.

Resolved, That the secretary of state be authorized to contract for seven hundred copies of the Maine state year book and legislative manual, containing in addition to the usual matter the rules and orders, committees of the legislature and state map, also one hundred copies eight vo. for the special use of the secretary of state's office, at an expense not exceeding one dollar and twenty-five cents per copy, the whole number to be delivered by May first, eighteen hundred and seventy-three.

Chapter 102.

Resolve ceding to the United States jurisdiction over certain lots in Mount Pleasant cemetery, in the city of Augusta.

Burial lots in
Mount Pleasant
cemetery.

WHEREAS, Certain lots situated in Mount Pleasant cemetery, in the city of Augusta, have been conveyed to the United States as burial places of deceased soldiers of the United States, by virtue of a deed recorded in book two hundred and seventy-four, page five hundred and thirty-one, in the registry of deeds for the county of Kennebec; therefore

—jurisdiction
ceded to United
States.

Resolved, That jurisdiction over said lots is hereby granted and ceded to the United States, provided that this state shall retain a concurrent jurisdiction with the United States in and over said lands so far that all civil processes and such criminal processes as may issue under the authority of this state, against any person or persons charged with crimes or offences, may be executed in the same manner as though this cession had not been granted.

Chapter 103.

Resolve in favor of John Gardner.

John Gardner,
in favor of.

Resolved, That the land agent be and he is hereby authorized to deed to John Gardner of Patten, in the county of Penobscot, lot numbered ninety-three in the town of Mount Chase, waiving further settling duties.
