**Chapter 119.**

**CHAP. 119.**

Resolve in favor of Charles W. Cobb.

*Resolved*, That the state pension of twelve dollars per month, granted to Charles W. Cobb, be increased to twenty dollars per month, commencing on the first day of January, in the year of our Lord eighteen hundred and seventy-three.

**Chapter 120.**

Resolve in favor of a road in the town of Mount Chase.

*Resolved*, That the sum of five hundred dollars be, and the same is hereby appropriated for the repair of road in the town of Mount Chase, in the county of Penobscot, to be expended under the direction of the land agent, in said town, on the road leading from the north line of Patten, through the town of Mount Chase on the East Branch road, so called.

**Chapter 121.**

Resolve in favor of the road leading from Monson to Greenville in the town of Shirley.

*Resolved*, That the sum of three hundred dollars be, and the same is hereby appropriated for the repair of the road leading from Monson to Greenville, in the town of Shirley, the same to be expended under the supervision of the selectmen of said town of Shirley.

**Chapter 122.**

Resolves abating part of the state tax of Sherman and assessing the same upon the town of Linneus.

*Resolved*, That the treasurer of state be, and hereby is authorized and directed to abate forty-nine dollars eighty-nine cents of the state tax assessed upon the town of Sherman, in the county of Aroostook, for the year one thousand eight hundred and seventy-two, and to send his warrant directed to the assessors of the town

of Linneus in said county, requiring them to assess the said sum of forty-nine dollars eighty-nine cents, upon the estates of said town of Linneus, and requiring the same to be collected and paid into the treasury of state on or before the first day of January next, being the proportion of state tax for the year eighteen hundred seventy-two, chargeable upon the estates of Linneus by resolve of the legislature approved February twenty-nine, eighteen hundred and seventy-two.

*Resolved*, That the county commissioners of the county of Aroostook, are hereby authorized and directed to abate the county tax of Sherman in said county, assessed upon the sum of eight thousand six hundred seventy-seven dollars, for the year one thousand eight hundred and seventy-two, and assess the same upon the town of Linneus in said county.

Resolve establishing the valuation of number five, range three, Somerset county.
