CHAP. 136.**Chapter 136.**

Resolve in favor of Henry F. Eaton, Charles H. Eaton, and T. W. Baldwin.

Henry F. Eaton  
and others, in  
favor of.

*Resolved*, That the sum of seven hundred and twenty-four dollars and fifty-three cents be paid from the treasury, out of any moneys not otherwise appropriated, to Henry F. Eaton, Charles H. Eaton and T. W. Baldwin, to defray expenses incurred by them in the survey of a township of land known and described as township number seven, range nine, north of Waldo patent; the same having been purchased by them of the state.

**Chapter 137.**

Resolve in favor of inhabitants of Eagle Island military plantation, county of Hancock.

Inhabitants of

*Resolved*, That there be paid out of the state treasury, from money not otherwise expended, to the inhabitants of Eagle Island military plantation or their agent, the sum of four hundred and thirty-three dollars and thirty-three cents, to reimburse said inhabitants for money expended by them during the war of eighteen hundred and sixty-one.

Brown of Washburn, in the county of Aroostook, lot numbered seventy-six, in the town of Washburn, provided he shall have paid for the same, within two years from the passage of this resolve, waiving further settling duties.
