The capital stock of said corporation shall not exceed the sum of Capital stock and twenty-five thousand dollars, to be divided into such number of shares as the company may determine, and said corporation may May hold real hold real and personal estate to the amount of said capital stock estate. with full power to manage and dispose of the same.

The first meeting of said corporation shall be held in First meeting, where held and the town of Fryeburg and shall be called by a notice thereof seven how called. days prior to said meeting, signed by one of the persons named in the first section of this act, a copy of which shall be given to each of the other corporators.

This act shall take effect when approved.

Chapter 440.

An act to incorporate the West Tremont Brick Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Thomas Clark, James T. Clark, J. R. Lunt, Frank W. Corporators. Lunt and Abner Pomroy, their associates, successors and assigns, are hereby constituted a corporation by the name of the West Corporate name. Tremont Brick Company, with all the powers and privileges and subject to all the liabilities provided or imposed on similar corporations by the laws of this state.

Said corporation is authorized to carry on the busi- Authorized to ness of manufacturing, selling and shipping brick, in the town of brick, &c. Tremont, in the county of Hancock, and may purchase and hold real and personal estate to an amount not exceeding ten thousand dollars.

Said company is also authorized and empowered to Authorized to build, maintain and extend a wharf on their own land, into the tide waters of Goose cove, at said West Tremont, five hundred feet.

build and extend

The capital of said corporation shall not exceed ten capital. thousand dollars, and shall be divided into such number of shares as the directors may determine.

SECT. 5. The first meeting of the corporation may be called at First meeting, how called and said Tremont by any one of the persons named in this act, by giving to each of the others a written notice of the time and place and purpose of the same, seven days before such meeting.

Sect. 6. This act shall take effect when approved.
