<b>CHAP. 594.</b>	<b>M. Livermore, S. D. Leavitt, C. C. Norton, W. C. Newcomb, G. G. Shead, A. H. Bibber, Simon Stevens and R. B. Clark, their associates, successors and assigns are hereby constituted a body</b>
Corporate name.	<b>politic and corporate, by the name of the Air Line Steamship</b>
Purpose of.	<b>Company, for the purpose of carrying on the business of navigation by vessels propelled by steam or otherwise, to and from Eastport, or to and from any other port in America or Europe, with all the powers and privileges, and subject to all duties and liabilities provided by the general laws of this state.</b>
Capital stock. Shares.	<b>SECT. 2. The capital stock of said corporation shall not be less than one thousand nor more than one hundred thousand shares of one hundred dollars each, and any person subscribing to said stock shall be personally liable to pay the assessments thereon, not exceeding one hundred dollars per share.</b>
First meeting, how called.	<b>SECT. 3. Any three persons named in this act may call the first meeting of said corporation, for the purpose of organizing the same, by giving notice thereof by publication in the Eastport Sentinel, a newspaper printed at Eastport, Maine, at least fourteen days before the appointed time of meeting.</b>
	<b>SECT. 4. This act shall take effect when approved.</b>

### Chapter 594.

An act to authorize the town of Litchfield to raise money for agricultural purposes.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Authorized to raise money for agricultural purposes.	<b>SECT. 1. The town of Litchfield, in the county of Kennebec, at its annual town meeting to be holden March, eighteen hundred and seventy-four, may, by a vote of two-thirds of the legal voters present and voting, raise a sum of money not exceeding four hundred dollars, for agricultural purposes, the same to be assessed, collected and paid into the town treasury in the same manner as other taxes.</b>
Money, how expended.	<b>SECT. 2. Said four hundred dollars shall be expended in defraying expenses already incurred in the erection of a building in which to hold agricultural exhibitions and which may accrue in the completion of said building. Said money to be drawn from the treasury only by order of the selectmen, which order shall be drawn in payment of bills properly vouched by a committee which shall have been duly elected by the town for the supervision of the expenditure of said four hundred dollars.</b>
—how drawn from the treasury.	<b>SECT. 3. This act shall take effect when approved.</b>
