CHAP. 5.**Chapter 5.**

An act authorizing the Cumberland Bone Company to build a wharf into tide waters, in the town of Boothbay.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Authorized to
erect a wharf.

SECT. 1. The Cumberland Bone Company, of Portland, are hereby authorized and empowered to erect and maintain a wharf, extending one hundred and twenty-five feet into tide waters, in front of their works, in the town of Boothbay.

Location.

SECT. 2. This act shall take effect when approved.

Approved January 28, 1875.

Chapter 6.

An act authorizing A. Martin and Sons to build and maintain a wharf in the tide waters of Rockport harbor.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Authorized to
build a wharf.

SECT. 1. Alexander Martin, Joseph H. Martin and Edward A. Martin, constituting the firm of A. Martin and Sons, of Rockport village, in the town of Camden, county of Knox, their heirs and assigns, are hereby authorized to build and maintain a wharf, extending from their own land from the eastern shore, into the tide waters of Rockport harbor, thirty feet.

Location.

SECT. 2. This act shall take effect when approved.

Approved January 28, 1875.

Chapter 7.

An act to authorize Joseph Church and Company to extend a wharf into tide water, in the town of Bristol.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Authorized to
construct a wharf.

SECT. 1. Joseph Church and Company, their heirs, successors or assigns, are hereby authorized and empowered to construct and maintain a wharf on the easterly side of their land, and easterly from their carpenter's shop situated thereon, in the town of Bristol, and to extend said wharf into the tide waters of Broad Bay sound one hundred feet, with a frontage of one hundred and sixty feet.

Location.

SECT. 2. This act shall take effect when approved.
