authorized to construct and maintain fish weirs, in the tide waters between Mount Desert and Bear Island, so-called, for the term of ten years, providing they do not interfere with navigation.

SECT. 2. This act shall take effect when approved.

Approved January 28, 1875.

Chapter 15.

An act authorizing George C. Lyman, Newton C. White and associates to build a wharf in tide waters at Sullivan.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. George C. Lyman, Newton C. White, their associates, heirs and assigns, are hereby authorized and empowered to build and maintain a wharf in tide waters at Sullivan, near the old ferry way at Meeting-House Point, so called, one hundred feet.

Authorized to build a wharf.

SECT. 2. This act shall take effect when approved.

Chapter 16.

An act to incorporate the Elliottsville Star Slate Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. Edson C. Buker, Rufus R. Drake, John B. Butter, Levi L. Lucas, John L. Field, Napoleon B. Turner, their associates, successors and assigns, are hereby incorporated by the name of the Elliottsville Star Slate Company, for the purpose of quarrying, manufacturing and marbleizing slate in the county of Piscataquis, to possess all the rights and privileges, and be subject to all the duties, liabilities and requirements of similar corporations.

SECT. 2. The capital stock of said corporation shall not exceed three hundred thousand dollars, divided into shares of twenty-five dollars each.

Capital stock and shares.

SECT. 3. Said corporation may purchase and hold personal and real estate to an amount not exceeding its capital stock, and have full power to manage and dispose of the same.

May purchase and hold real estate.

SECT. 4. The officers of said corporation shall consist of a president, clerk and treasurer, and not less than three directors, also such other officers and agents as shall be required by the by-laws of said company.

Officers.

CHAP. 17.

By-laws, &c.

SECT. 5. Said company shall have full power to make and enforce all necessary regulations and by-laws for the management of its affairs not repugnant to the laws of this state.

First meeting,
how called.

SECT. 6. Either of the persons named in section one may call the first meeting for the purpose of organizing said corporation, by giving notice to each of the other persons named in section one, of the time and place of meeting at least seven days before the time of organization, at which time the manner of calling future meetings may be determined.

Chapter 17.

An act to incorporate the Centre Livermore Cheese Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Corporators.

SECT. 1. J. H. Bigelow, Millitt Cummings and John W. Bigelow, their associates, successors and assigns, are hereby created a body politic and corporate by the name of the Centre Livermore Cheese Company, with all the powers and privileges, and subject to all the duties and liabilities provided by the laws of this state concerning manufacturing corporations.

Corporate name

Powers, duties,
&c.

Purposes of.

SECT. 2. Said corporation is hereby authorized to manufacture cheese, and to transact any other business usually carried on by cheese factories or corporations for the purpose of associated dairying.

Capital stock and
shares.

SECT. 3. The capital stock of said corporation shall not exceed the sum of five thousand dollars, to be divided into such number of shares as the company may determine; and said corporation may hold real and personal estate to the amount of said capital stock, with full power to manage and dispose of the same.

First meeting.

SECT. 4. The first meeting of said corporation shall be held in the town of Livermore, and shall be called by a notice thereof at least seven days previous to said meeting, signed by one or more of the persons named in the first section of this act, a copy of which shall be given to each of the other incorporators.

SECT. 5. This act shall take effect when approved.
