#### Chapter 18.

Снар. 18.

An act to incorporate the Waterville Slate Company.

Be it enacted by the Senate and House of Representatives in Legistature assembled, as follows:

Sect. 1. William G. Jones, Edwin Smiley, S. Clifford Belcher, Corporators. Samuel Belcher, Eben F. Pillsbury, Lucien B. Pillsbury, Richard Griffeth and William E. Dresser, their associates, successors and assigns, are hereby created a body politic and corporate, by the name of the Waterville Slate Company, for the purpose of quarry- Corporate name. ing, manufacturing and selling slate in its various forms, with all Purpose of. the powers and privileges, and subject to all the duties, liabilities and requirements of similar corporations by the laws of this state.

Said corporation may purchase and hold real and May purchase and hold real and may be dealed and hold real and hol personal estate to an amount not exceeding at any one time two personal estate. hundred and fifty thousand dollars, with full powers to manage and dispose of the same.

Sect. 3. Said corporation may divide their original stock into original stock such number of shares, and provide for the sale and transfer shares. thereof, in such manner and form as said corporation shall from time to time determine, not repugnant to the laws of this state.

William G. Jones is hereby authorized to call the first First meeting, meeting of said corporation, at Farmington, by giving to each person named in this act a written notice of the time and place of holding said meeting, seven days before holding the same; and a majority of the corporators named in this act, being present at any meeting, are hereby authorized to legally organize under this act.

Sect. 5. This act shall take effect when approved.

#### Chapter 19.

An act additional to an act entitled "an act to enable the city of Bangor to aid the Bangor and Piscataquis Railroad Company."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

The city of Bangor is hereby authorized to make a Loan to Bangor further loan of its credit to the Bangor and Piscataquis Railroad Railroad Co. Company, in addition to the loan now authorized by chapter six hundred and seventy-six of the special laws of eighteen hundred and seventy-one, to which this act is additional, to aid said company in the construction of its proposed line of railroad from its present terminus in Abbot to Moosehead lake, substantially
