statutes, and in all the general laws which now are or hereafter CHAP. 71. may be in force relating to such corporations.

SECT. 2. The capital stock of said corporation shall be not Capital stock. exceeding two hundred thousand dollars.

SECT. 3. The said corporation shall be entitled to purchase May hold real and hold real estate not exceeding in value one hundred thousand estate. dollars, and personal estate not exceeding in value fifty thousand dollars.

SECT. 4. This act shall take effect when approved.

Chapter 71.

#### An act to incorporate the Saccarappa Savings Bank.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. George Warren, James Haskell, George H. Raymond, Corporators. James Pennell, Leander Valentine, J. R. Andrews, Ivory Hezelton, John Cloudman, Ephraim J. Pennell and F. M. Ray, their associates, successors and assigns, are hereby created a body politic and corporate by the name of the Saccarappa Savings Corporate name. Bank, to be located in the town of Westbrook, in the county of Location. Cumberland, with all the powers, rights and privileges conferred Rights and upon similar institutions by the laws of this state, and subject to all the duties and liabilities thereof.

SECT 2. Said corporation shall receive on deposit sums of Deposits. money as small as fifteen cents, and may purchase and hold real and personal estate, with full power to manage and dispose of the same.

F. M. Ray, named in this act, is authorized to call **Sect.** 3. the first meeting of said corporation, by giving seven days' personal notice to each of the other corporators; and at such meeting hy-laws may be adopted, and all necessary officers chosen for managing the affairs of said corporation.

SECT. 4. The said corporation is hereby authorized to receive deposits of money, and to issue certificates therefor, and such deposits of money shall be used as the trustees shall judge most for the benefit of said corporation; and such deposits may be withdrawn at such reasonable times, and in such manner, as said corporation shall appoint, and the net income and profit thereof shall be divided among the persons making such deposits,

their executors, administrators or assigns, in just proportion, after

CHAP. 72. deducting the necessary expense of carrying on the affairs of the corporation.

SECT. 5. This act shall take effect when approved.

#### Chapter 72.

An act additional to an act entitled "an act to supply the city of Bangor with pure water."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. The time specified in said act for the completion of the water works therein provided, except so far as the same authorizes the taking water from Hatcase pond, in Dedham, and its tributaries, is hereby extended three years, and the time allowed the city of Bangor for taking the same is extended five years from the approval of this act.

SECT. 2. Any party injured by the taking, using or appropriating by said company, of the waters of Fitz pond, in Clifton, as named in the amendment to said act, may have and pursue the same remedies as are provided for damages for laying out of high-ways.

SECT. 3. Said company may issue its bonds for the construction of its works, at such rates and time as it may deem expedient, not exceeding in amount the sum of three hundred thousand dollars, and secure the same by a mortgage of the franchises and property of said company.

Chapter 73.

An act to incorporate the Bristol Agricultural Society and Farmers' Club.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. Thomas Herbert, Denis R. Hanly, Calvin C. Robbins, James H. Little, James H. Varney, John M. Bryant, Joseph Hunter, Leander Morton, A. F. Nichols, Joshua Thompson, L. B. Morton, Albert C. Yates, Benjamin Smith, their associates and successors, of the town of Bristol, in the county of Lincoln, be and are hereby constituted a body corporate by the name of the Bristol Agricultural Society and Farmers' Club, with all the
