#### Chapter 78.

An act to incorporate the Winterport Savings Bank.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Corporators.

SECT. 1. E. C. Arey, T. A. Snow, A. E. Fernald, Job Lord, Elbridge Fernald, James Haley, R. A. Rich, C. P. Rich, J. C. Atwood, George Dudley, George White, Freeman Littlefield, James Murch, H. H. Davis, F. W. Ritchie, Bedfield Plummer, Daniel Dyer, John W. Sproul, N. H. Hubbard, John Stokell, N. E. Hall, Edward Mansfield, Ezra Manter, their associates and successors, are hereby incorporated into a body politic and corporate by the name of the Winterport Savings Bank, with all the rights and privileges and subject to all the liabilities and duties incident to similar institutions in this state, with full power by that name to prosecute and defend suits at law and in equity, to have and use a common seal, to elect such officers as are required by the laws of this state, and others that may be necessary for the transaction of business, to receive deposits and to use and invest the same as they shall deem for the best interests and benefits of depositors, to make, establish and enforce by-laws for the management of the concerns of the corporation, not repugnant to the laws of this state. Said bank shall be established in the town of Winterport.

Sect. 2. The first meeting of said corporation may be held at such time and place as the first five corporators may designate, by giving notice thereof seven days previous, by publishing the same in the Bangor Daily Whig and Courier, a public newspaper published in the city of Bangor. At said meeting, and every subsequent annual meeting, new members may be elected by ballot. It shall require at least seven of the corporators or their associates to constitute a quorum.

SECT. 3. All deeds of conveyance or other instruments made in behalf of the corporation, shall be sealed with the corporate seal, and when in pursuance of any vote of the corporation, shall be valid to convey property or bind the corporation.

Sect. 4. This act shall take effect when approved.

Approved February 10, 1875.
