Chapter 79.**CHAP. 79.**

An act authorizing Michael Hurley to extend his wharf at the west end of Union river bridge, in Ellsworth, into the waters of Union river.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. Michael Hurley, of Ellsworth, is hereby authorized to extend his wharf thirty-six feet into the waters of Union river from the west bank of said river, and ninety feet up the river, beginning on the north side of Union river bridge.

SECT. 2. This act shall take effect when approved.

Chapter 80.

An act to authorize William F. Desisles and others to build a wharf in tide waters at Lamoine.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. William F. Desisles, Calvin Y. Huckins, William Desisles, Frank L. Winterbotham and their associates, are authorized and empowered to build and maintain a wharf into tide waters, in the town of Lamoine, about one hundred and fifty feet from the shore of William F. Desisles.

Authorized to build wharf.

SECT. 2. This act shall take effect when approved.

Chapter 81.

An act to incorporate the South Pittsfield and Burnham Cheese Factory Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. Charles A. Milliken, Charles H. Foster, Hartley B. Libby, W. G. Foster, Lorenzo Baxter, A. W. Weymouth, Chandler Noyes, Hiram Berdeen, Edward Milliken, Alpheus Goodrich, their associates and successors, are hereby constituted a corporation by the name of the South Pittsfield and Burnham Cheese Factory Company.
