CHAP. 124. granted to said company shall continue and be in force during said term of extension of time.

Proviso

- Sect. 2. Provided that said company shall not construct any bridge across the Belfast bay or harbor at any point below Lane's wharf, so called.
 - SECT. 3. This act shall take effect when approved.

Chapter 124.

An act to incorporate the Cumberland Fish Company,

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Cornerators.

Corporate name.

Purpose of. Powers, privi-leges, liabilities, &c.

Capital stock.

May purchase and hold real estate.

Exclusive rights not conferred.

Sect. 1. Hezekiah Winslow, Mark P. Emery, James M. Kimball, their associates and successors, are hereby made a corporation by the name of the Cumberland Fish Company, for the purpose of breeding and cultivating fish, with all the powers and privileges and subject to the duties, restrictions and liabilities set forth in the forty-sixth chapter of the revised statutes, and in all the general laws which now are or hereafter may be in force, relating to such corporations.

The capital stock of said corporation shall be not Sect. 2. exceeding twenty thousand dollars.

The said corporation shall be entitled to purchase and hold real estate not exceeding in value ten thousand dollars, and personal property not exceeding in value ten thousand dollars.

Sect. 4. This act shall not be construed to confer upon said corporation any exclusive rights or privileges in any of the waters of the state.

Sect. 5. This act shall take effect when approved.

Chapter 125.

An act additional to "an act establishing the Portland and Rechester Railroad Company."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Time to change location extended

The time within which the change of the location of the track of the Portland and Rochester Railroad Company, between Cumberland Mills, in the town of Westbrook, and their depot in the city of Portland, is hereby extended for the term of Chap. 126. three years from the first day of February next.

The Portland and Rochester Railroad Company is Authorized to hereby authorized to locate, construct, and finally keep in repair road. one or more sets of rails, on a continuation of its line of railroad. beginning at a convenient point northeasterly of Deering's bridge, Route. in the city of Portland, on the located line of the road between said bridge and the building now used for a depot, and thence continuing in a northeasterly direction to a point of connection with said located road at Wilmot street, or to some other point on what is known as the marginal way; provided that nothing in the Proviso. provisions of this bill shall give the Portland and Rochester Railroad Company any power to take and occupy any portion of what is called the marginal way, without first obtaining the consent of the mayor and aldermen of the city of Portland; and for these purposes said company shall have the right to purchase, or to Right to take and take and hold so much of the land and other real estate of private persons and corporations as may be necessary for the alteration, location, construction and convenient operation of said road; the width of land thus taken shall not be over sixty-six feet; the location to be made on or before the first day of February, eighteen hundred and seventy-six, and under the authority hereby given, is to be subject to the provisions of law regulating the construction of railroads in this state, and the provisions of the charter of said railroad company, or of the York and Cumberland Railroad Company; provided that any clause contained in the charter of Proviso; not exthe Portland and Rochester Railroad Company, or the York and empt from taxa-Cumberland Railroad Company, exempting said company from taxation by the state, shall not extend to this act; and in case the Portland and Rochester Railroad Company fails to locate as above, or fails to construct on or before January first, eighteen hundred
