### PRIVATE AND SPECIAL LAWS

Sect. 2. Said corporation may hold, for the purposes afore. CHAP. 128. said, real and personal estate, by purchase, gift, devise or other- May hold real and wise, to such an amount that the net income thereof shall not in any one year exceed thirty thousand dollars, and the management of all said property may be committed by said corporation to a clerk or secretary, treasurer, trustees, committee or other officers or agents thereof.

Property, how managed.

This corporation, at any legal meeting thereof after May consolidate with similar cor-SECT. 3. its organization, is hereby fully authorized and empowered by a porations. major vote of its members present at such meeting, to consolidate with the Yearly Meeting of Friends for New England, incorporated by the legislature of Rhode Island, and now in operation in that state, so as to constitute but one corporation, as nearly as may be, with full authority to hold corporate meetings in Rhode Island, as well as in this state, and to transact any corporate business in said state, so as to be binding upon this corporation and all persons interested therein; and this corporation shall hold all its property subject to the same purposes and trusts as are or may be specified in the said Rhode Island charter, provided that Proviso. real and personal estate held by said corporation shall not be exempt from taxation.

The Yearly Meeting of Friends for New England, a Friends for New corporation established by the legislature of Rhode Island, and England authorized to hold now in operation in that state, is hereby authorized to hold its in Maine. annual meetings in the State of Maine from time to time, as they shall see fit, and transact therein any business that may come before them, the same as if such meetings were held in the State of Rhode Island.

SECT. 5. This act shall take effect when approved.

#### Chapter 128.

An act to incorporate the Camden Marine Railway Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. Isaac Coombs, Holley M. Bean, Elbridge G. Knight, Corporators. Joseph F. Stetson, James Frye and Israel Decrow, their associates, successors and assigns, are hereby created a body politic and corporate by the name of the Camden Marine Railway Company Corporate name. of Camden, for the purpose of building and of repairing marine

vessels, with all the powers and privileges and subject to all the duties, liabilities and requirements of similar corporations by the laws of this state.

Right to build and maintain marine railway. SECT. 2. Said company may have the right to build and maintain a marine railway and a wharf extending into tide waters so far as to reach the channel determined by the survey of General Thom for the United States government. Said marine railway and wharf to be located upon Eaton's point, so called, and south of the wharf of Sanford's independent steamboat company.

· Location of.

May purchase and hold real and personal estate. SECT. 3. Said company may purchase and hold real and personal estate to an amount not exceeding at any one time two hundred and fifty thousand dollars, with full powers to manage and dispose of the same.

Shares.

SECT. 4. Said company may divide their original stock into such number of shares, and provide for the sale and transfer thereof, in such manner and form as said company shall from time to time determine, not repugnant to the laws of the state.

First meeting, how called. SECT. 5. Isaac Coombs is hereby authorized to call the first meeting of said company, at Camden, by giving to each person named in this act a written notice of the time and place of holding such meeting, seven days before holding the same, and a majority of the corporators named in this act being present at any meeting are hereby authorized to legally organize under this act.

SECT. 6. This act shall take effect when approved.

#### Chapter 129.

An act to legalize the doings of L. M. Partridge, as justice of the peace and quorum.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Lewis M. Partridge, certain acts of, to make valid. Sect. 1. The acts and doings of Lewis M. Partridge, as justice of the peace and quorum, within and for the county of Waldo, from May eighth, eighteen hundred and seventy-three, to January twentieth, eighteen hundred and seventy-five, are hereby made legal and valid.

Sect. 2. This act shall take effect when approved.
