CHAP. 17.**Chapter 17.**

Resolve in favor of Ether W. Sprague.

Ether W.
Sprague, in favor
of.

Resolved, That the land agent be, and he is hereby authorized to convey by deed to Ether W. Sprague lot numbered thirty-nine in the town of Easton, in the county of Aroostook, waiving further duties.

Approved February 12, 1875.

Chapter 18.

Resolve in favor of the town of Kingsbury.

Road in Kings-
bury, in favor of.

Resolved, That the sum of five hundred dollars be, and the same is hereby appropriated to be expended under the direction of the land agent upon the New England road, so called, in the town of Kingsbury.

Approved February 12, 1875.

Chapter 19.

Resolve in favor of the county of Knox.

Knox county, in
favor of.

Resolved, That there be paid out of the state treasury, to the treasurer of the county of Knox, the sum of three thousand five hundred and ninety-four dollars and ninety-nine cents, it being the amount of costs and expenses incurred in the supreme judicial court in that county, at the September term, eighteen hundred and seventy-four, in the trial of Charles Tilton Robbins for the crime of murder.

Chapter 20.

Resolve in favor of Crystal plantation in county of Aroostook.

Crystal planta-
tion, in favor of
roads in.

Resolved, That there be appropriated from the state treasury, to Crystal plantation, in the county of Aroostook, the sum of two thousand and five hundred dollars, under the following restrictions, limitations and conditions, viz: that if during the year eighteen hundred and seventy-five, the plantation of Crystal shall cut out and grub the Molunkus Valley road, as laid out by the commissioners of Aroostook county, through its whole length in

said plantation, and of sufficient width to construct a turnpike road thirty feet in width the entire distance in said plantation, then said plantation shall receive the sum of twelve hundred and fifty dollars; and if said plantation shall, during the years eighteen hundred and seventy-six and seven inclusive, construct a good and sufficient turnpike road therein, as above indicated, thirty feet in width, with all the requisite bridges and culverts in its entire length in said plantation, to the acceptance of the land agent or other person appointed by the governor for said purpose, then, upon completion of said road, said plantation shall receive a further sum of twelve hundred and fifty dollars, the whole of which sum the governor is authorized and required to draw his warrants for, in the manner and time herein prescribed, and this sum shall be in full for the construction of said road through said plantation.

Chapter 21.

Resolve making appropriation for the Penobscot tribe of Indians.

Resolved, That there be paid from the state treasury to the agent of the Penobscot tribe of Indians, to be appropriated for the benefit of said tribe as follows: Forty-four hundred and twenty-nine dollars and seventy cents, amount of interest on their trust fund held by the state for the benefit of said tribe; eighteen hundred dollars for their annual annuity; six hundred dollars for agricultural purposes; four hundred dollars for bounty on crops; three hundred dollars for salary of agent; one hundred and fifty dollars to pay competent persons to be employed by the agent to assist and instruct said Indians in their agricultural labors, as follows: seventy-five dollars on Oldtown and Orson islands; thirty-seven dollars and fifty cents on Hemlock, Sugar and Olamon islands; thirty-seven dollars and fifty cents on Mattanawcook island; on the same conditions as required by chapter ninety-six of the resolves of eighteen hundred sixty-seven. The following sums appropriated to be paid from their shore rents: Four hundred dollars for schools; two hundred and fifty dollars on Oldtown island, under the supervision of the superintending school committee of Oldtown; eighty dollars on Mattanawcook island, under the supervision of the superintending school committee of Lincoln; seventy dollars on Olamon island, under the supervision of the superintending school committee of Greenbush, and said committees are required to report as directed in resolve approved
