Chapter 73.

CHAP. 73.

Resolve in favor of the state reform school.

Resolved, That there be and hereby is appropriated the sum of eighteen thousand dollars for the uses of state reform school, to meet the current expenses of the ensuing year, and make the improvements indicated in the accompanying report.

Chapter 74.

Resolve in favor of eastern state normal school, at Castine.

Resolved, That the sum of six thousand and one hundred dollars for teachers' salaries, two hundred and seventy-five dollars for fuel, two hundred and fifty dollars for janitor, three hundred and fifty dollars for apparatus, five hundred dollars for library, thirty-seven dollars and fifty cents for advertising, and fifty dollars for contingent fund, be and the same is hereby appropriated for the benefit of the eastern state normal school at Castine.

Eastern state normal school, in favor of.

Chapter 75.

Resolve in favor of the western state normal school at Farmington.

Resolved, That the sum of five thousand eight hundred dollars for teachers' salaries, three hundred dollars for fuel, three hundred dollars for janitor, two hundred and fifty dollars for apparatus, thirty-seven dollars and fifty cents for advertising and fifty dollars for contingent fund, be and the same is hereby appropriated for the benefit of the western state normal school at Farmington.

Chapter 76.

Resolve in favor of the town of Island Falls.

Resolved, That the lands belonging to the state, which lie in the town of Island Falls, county of Aroostook, that are unfit for settlement, be sold by the land agent, and the proceeds be expended on

Island Falls, relating to sale of lands in.

CHAP. 77. roads and bridges in said town, under the direction of the land agent, or some person by him appointed to expend the same.

Chapter 77.

Resolve in favor of the Maine industrial school for girls.

Industrial school

Resolved, That the sum of five thousand dollars be and the same is hereby appropriated for the use of the Maine industrial school for girls, at Hallowell, to meet the current expenses of the ensuing year, the same to be expended by the trustees of said school; *provided* that said trustees will make to the governor and council a full and detailed report of the expenditure of the above appropriation.

Chapter 78.

Resolve in favor of the town of Roxbury.

Town of Roxbury,
in favor of.

Resolved, That there be paid from the state treasury, to the town of Roxbury, the sum of five hundred dollars, and the same is hereby appropriated for the purpose of liquidating any of the liabilities of said town, for expenses incurred by repair of highways, pauper expenses, or other town charges.

Chapter 79.

Resolve in favor of the Maine general hospital, at Portland.

Resolved, That the sum of ten thousand dollars be and the same is hereby appropriated for the purpose of finishing and furnishing the central building of the Maine general hospital, to be paid whenever satisfactory evidence shall be furnished to the governor and council that said appropriation has been expended for the purposes enumerated in this resolve.
