forty-three cents; to finish workshop, six hundred dollars; to repair wall, two thousand dollars; to repair prison, fifteen hundred dollars; to build stable, five hundred dollars; to make reservoir, two hundred dollars; for general repairs, eight hundred and seventy-eight dollars and fifty-seven cents; for school books, to be expended under direction of the teacher, D. J. Starrett, one hundred dollars.

Chapter 83.

Resolve providing for the payment of the expenses of Martin H. Kiff.

Martin H. Kiff, to pay expenses of sickness. Resolved, That the treasurer of state be authorized to audit and allow, and pay the necessary expenses incurred by W. M. Thayer, for board, nursing and medical attendance furnished to Martin H. Kiff, a member of this house, from Vinalhaven, now confined to his room by sickness, requiring extraordinary care. The sum hereby appropriated not to exceed five hundred dollars.

Chapter 84.

Resolve in aid of bridge over Ouilette stream.

Bridge over Ouilette stream, in aid of. Resolved, That there be paid from the state treasury one hundred dollars, to the treasurer of St. Francis plantation, in aid of the bridge over Ouilette stream, when the commissioners of Aroostook county certify to the treasurer of state that said bridge is completed to their acceptance.

Chapter 85.

Resolve in favor of the secretary of the senate.

Samuel W. Lane, in favor of. Resolved, That there be paid from the treasury of the state, out of any money not otherwise appropriated, to Samuel W. Lane, secretary of the senate, for furnishing forty-four daily papers to members and officers of the senate, one hundred and seventy-three daily papers to members and officers of the house, six daily papers

to the executive council, during the present session; for advertising legislative notice relative to the reception and reference of petitions for private legislation in the Bangor Daily Whig and Courier, the Daily Eastern Argus, Lewiston Daily Journal, and Bangor Daily Commercial, and for postage, the sum of four hundred and thirty-five dollars and fifty-seven cents.

Approved February 24, 1875.

Chapter 86.

Resolve in favor of Thomas Mathison.

Resolved, That the sum of one hundred and fifty dollars be paid Thomas Mathito Thomas Mathison in full for stumpage cut and hauled from lot number sixty-one, in Oakfield plantation, by permit from the state in eighteen hundred and sixty-six, after said Mathison had purchased said lot from the state.

Approved February 24, 1875.

Chapter 87.

Resolve in favor of Avis W. Young.

Resolved, That the land agent be and he is hereby authorized to Avis W. Young, convey by deed, to Avis W. Young, a lot of land one hundred and sixty acres, to be selected from any settling land in the county of Aroostook.

Chapter 88.

Resolve making appropriation for the propagation of fish.

Resolved, That the sum of fifteen hundred dollars be and is Propagation of hereby appropriated, to be expended under direction of the fish fish, appropriation for. commissioners, for the propagation of fish.
